2. Government after examination of the matter, hereby constitute the District Level Covid Death Ascertainig Committee (CDAC) for issuance of Official Document for Covid-19 Death to the next kin of the deceased with the following members:

3. The District Level COVID Death Ascertainig Committee (CDAC) shall follow the procedure outlined below:

- I. The next of kin of the deceased shall submit a petition to the District Collector for issuance of the appropriate Official Document for COVID-19 Death.
- II. The Official Document for COVID-19 Death shall be issued in the format annexed to these Guidelines by the aforesaid District-Level Committee after due examination and verification of all facts.
- III. The Official Document for COVID-19 Death shall also be communicated to Chief Registrar of State and Registrar of Births and Deaths, who issued the death certificate.
- IV. The Committee shall also examine the grievances of the next of kin of the deceased, and propose necessary remedial measures, including issuance of amended Official Document for COVID-19 Death after verifying facts in accordance with these guidelines.

V. The application for issuance of Official Document for COVID-19 Death and for redressal of grievances shall be disposed of within (30) days of submission of the application/ grievance.

4. All the Collectors & District Magistrates in the State shall take necessary action accordingly.
