ORDER :-

The Vice Chairman & Managing Director, Sports Authority of Andhra Pradesh, Vijayawada has submitted the proposal for creation of Sports Clubs in each Village / Ward Sachivalayam in the State to create awareness among the people to participate in sports, fitness and recreational activities to make them fit and healthier and for development of sports activities and promotion of rural talented player. Further, he has furnished the following guidelines and job chart for development of sports clubs activities in each Village / Ward Sachivalayam through out the State and requested to issue suitable orders for assigning job chart to the one employee in each Village / Ward Sachivalayam on creation of Sports Clubs and activities of Sports Clubs at the earliest.

GUIDELINES TO SPORTS CLUBS AT VILLAGE LEVEL

1. The aim of the establishment of Sports clubs is to create awareness among the people to participate in sports, fitness and recreational activities to make them fit and healthier.
2. All Village sports clubs shall be established discipline wise.
3. The sports club created for development of sports activities and promotion of rural talented players by conducting tournaments monthly.
4. The sports club will organize the sports activities in the discipline
5. Every three months the sports clubs shall organize Inter Club tournaments at Mandal/Constituency/District level in the discipline.

6. The Sports clubs shall maintain registers of player's achievements at District, State and National tournaments in the discipline with SAAP.
7. With the help of Panchayat Sarpanch, MPTC, MPP, ZPTC and Hon'ble MLA shall attract more sponsorship to develop the infrastructure of the discipline and organizing tournaments and leagues.
8. The sports clubs have to conduct tournaments in the names of public representatives, businessman, philanthropists, soft ware engineers, retired officers and NRI's on their birthdays and memorial tournaments by taking sponsorship.
9. The sports clubs shall take the help of Panchayat Sarpanch to tap the funds from Gram Panchayats for their contribution to sports development.
10. Panchayats can incur sports expenditure in the head of development of other departments need.
11. All the members will elect President, Vice-President, Secretary, Joint Secretary, treasurer and other executive members in the body.
12. On the occasion of Ugadi, Sankranthi, Women's Day, Republic Day, and Independence Day competitions can be conducted in the discipline.
13. Talented players from rural areas will be encouraged for participation in Selections at Mandal, Constituency, District and State level.
14. Mandal Parishads & Zilla Parishads have to incur 4% on Sports from its funds and they can conduct inter-village clubs sports.

JOB CHART OF PANCHAYAT SPORTS AUTHORITY

- Panchayat/Village Sports Authorities responsibilities are to encourage all Children, Youth, Senior Citizens and women to participate in Sports/ Games.
- Panchayat Sports Authorities will co-ordinate between Mandal Sports Authority (MSA) and Village schools, (Both Government and Private) management for active participation at all level competitions.
- Monthly reports on Sports activities, participation of village population and other events related to Sports should be submitted to the concerned District Sports Authorities.
- Conduct of Inter Sports School competitions at village level to bring the best talented person to participate at Mandal and District level competitions.
- To promote the martial arts in the Village and organize competitions on weekly basis at Village level and organize the Traditional Events also.
- Conduct of the weekly competitions among rural youth (B&G) age group wise in every Village panchayat in the selected popular disciplines.
- Conduct of Walking, jogging competitions among senior citizens in the Village based on the concept of “Right to play perform and peak for every Citizen”.
- To accept endowments, bequests, donations, trophies, grants and transfer of any movable and immovable properties in favour of Panchayat Sports Authority.
- Separate account shall be open in the name of Panchayat/Village Sports Authority.
- Panchayat Sports Authority shall meet once every month and review the promotion of sports activities in private schools, Government Schools at village level as per the schedule/sports calendar of the District Sports Authority.
- To approve and present audited statements of accounts and utilization certificates to the concerned District Sports Authority.

JOB CHART OF MANDAL SPORTS AUTHORITY

- To promote and organize competitions in indigenous games.
- To prepare and present proposals to the District Sports Authority for construction of stadia, indoor stadia, swimming pool, play fields and the like in the mandal.
- To promote and organize women sports, children sports and tribal sports in the mandal.
- To promote martial arts, if any, in the mandal.
- To approve the budget estimates and the revised budget estimates of the Mandal Sports Authority.
- To raise finances by arranging leasing out the properties owned by or vested in it in the manner prescribed.

- To augment income of the Mandal Sports Authority by conducting tournaments, matches and other games and sports events and arranging the sale of tickets in connection therewith.
- To accept endowments, bequests, donations, trophies, grants and transfer of any movable and immovable properties made to it.
- To approve and present audited statements of accounts and utilization certificates to the District Sports Authority.
- To coordinate all games, sports and physical education activities in all educational institutions whether or not receiving grants from the government; and to supervise that allotted to these institutions for the promotion of games, sports and physical education are properly utilized.
- To exercise such other powers and perform such other functions as may be conferred or enjoined upon it by or under this Act.

2) Government, after careful examination of the proposal, hereby permit the Vice Chairman & Managing Director, Sports Authority of Andhra Pradesh, Vijayawada for assigning job chart to the one employee in Village / Ward Sachivalayam on creation of sports clubs and activities of sports clubs for creating awareness among the people to participate in sports, fitness and recreational activities to make them fit and healthier and for development of sports activities and promotion of rural talented players.

3) The Vice Chairman & Managing Director, Sports Authority of Andhra Pradesh, Vijayawada shall take necessary action accordingly.
