ORDER:

Hon'ble Chief Minister is scheduled to release the next instalment of Jagananna Vidya Deevena in the fourth week of July 2021. As per instructions issued in the meeting held on the preparatory activities to be taken up prior to this, the following are the steps to be taken.

- Six step validation of all JVD applications with updated data bases on the income eligibility conditions as mentioned in G.O Ms.No.115 of SW Dept dated 30-11-2019. This is found essential, since in the field survey conducted, it came to notice that few ineligible students are also applying with incorrect certificates or by hiding the facts— To be done by the Jnanabhumi technical team of APCFSS.
- Electronic acknowledgment of receipt of the first instalment amount for 2020-21 from the mothers – by the WEAs/WESs through the apk developed for this purpose.
- Bio-metric authentication of the students by the WEAs/WESs through the apk developed for this purpose
- Wherever the WEAs/WESs have knowingly recommended the ineligible applications previously, necessary disciplinary action needs to be taken against them, so that the process of verification gets streamlined.
- Where the mothers are yet to pay the first quarter fees to the colleges even after release of the amount to their accounts by the government, such cases need to be followed up by the WEAs/WESs. If there is any misuse of the money, such mothers need to be informed that there is a possibility of not releasing the second instalment to them, if they do not pay the fee to the college without valid reason. The list of mothers who are yet to pay the fee to the colleges,

though money was released to their account, will be shown in the login of WEA/WES.

To implement the above steps, the following schedule is given.
