Your kind attention is invited to the reference 1<sup>st</sup> cited.The Health department, Government of India has directed to conduct Ayushman Bhavah programme and to declare Ayushman Gram Panchayat/Ayushman Urban Ward by saturating the enrolment and distribution of Ayushman - Dr.YSR Aarogyasri cards.

It is submitted that out of 1.94 lakh eligible beneficiaries based on 2011 SECC data 1.31 lakh have been enrolled. The balance 63 lakh beneficiaries have to be enrolled now. The progress so far is as follows.
