Adverting to the references 1st & 2nd cited above, wherein, the Government of Andhra Pradesh has announced a new flagship initiative, "THALLIKI VANDANAM", to be implemented from the academic year 2025-26, with the objective of providing financial assistance to every mother/guardian to encourage and support the enrollment and continued education of their children from Classes I to XII in Schools and Junior Colleges.

In this regard, the Government has issued detailed guidelines for the implementation of the scheme "THALLIKI VANDANAM". In this connection, vide reference 3rd cited above, the GSWS Department has established a robust online grievance redressal mechanism with dashboards to ensure that all grievances are redressed in a transparent and time bound manner as per the following time lines:

2	Publication of eligible and ineligible lists at Sachivalayams	12.06.2025
3	Receiving of Objections/Grievances at Sachivalayams	12.06.2025 to 20.06.2025
4	Verification of grievances and preparation of supplementary eligible list	21.06.2025 to 28.06.2025
5	Publication of eligible 1st class and Jr. Inter student lists at Sachivalayams	30.06.2025
6	Disbursal of financial assistance to the eligible beneficiaries.	05.07.2025

In view of the above, it is informed that, a Grievance redressal module will be enabled in Beneficiary Management Portal <https://gsws-nbm.ap.gov.in/NBM/Home/Main> with logins to respective Digital Assistant in Village Secretariats and Ward Welfare & Development Secretary in Ward Secretariats with effect from 13-06-2025. The concerned DAs/WWDSs must raise the Grievance related Service request if required in the APSeva Web Portal.

In view of the above, all the Collector and District Magistrates in the State are requested to ensure that all stakeholders are sensitized, and the guidelines and SoP are strictly adhered to at all levels.
