The Content of COP & questionnaire is as follows –

ROFR Pattas: Recognition of Forest Rights (ROFR) pattas are the forest lands distributed to tribal people who used to cultivate forest lands before 2005.

DKT Pattas: Darakastu land pattas are the pattas assigned to BPL people

III. **National Payment Corporation of India Survey (NPCI)** :Aadhaar based Direct Benefit Transfers are the mode of transferring of monetary scheme benefits directly in to beneficiary active account without taking bank details. For Aadhaar Based DBT, Beneficiaries are expected to map their Aadhaar seeded active bank account with National Payments Corporation of India (NPCI).

Case I: Active status means Aadhaar linked bank account is mapped with NPCI and eligible for Direct Benefit Transfers.

Case II: If it is "Inactive Aadhaar error", reasons and how to activate

Q: What is reason of inactive Aadhaar Card?

A: Reasons for Inactive Aadhaar Card are:

- a. Baal Aadhaar should do Mandatory Biometric update after 5 years and 15 year otherwise it will inactive automatically.
- b. If not use of Aadhaar Card for 5-10 years as identity proof.

Q: How to activate inactive Aadhaar Card?

A: By updating Biometrics, Aadhaar card status will change from inactive to active

Case III: If it is “Not mapped Aadhaar” error, reasons and how to activate

Q: What is reason of “Not mapped Aadhaar Card”?

A: Consent Form not given in Bank to Map Aadhaar card with NPCI

Q: How to Map Aadhaar Card with Bank?

A: Submitting the consent form at Bank to map Aadhaar with NPCI
