



IMPORTANT INSTRUCTIONS FOR VILLAGE VOLUNTEERS / MAHILA POLICE

Mandatory Documents to be collected from agrigold depositors

1. Aadhaar Card xerox copy
2. Note aadhaar number on each and every document collected
3. Depositor name should be matched with aadhaar collected
4. Capture all original agrigold document images in to mobile application (one scheme per depositor)
5. Collect all physical documents that are only eligible between 0 to Rs 20,000

Instructions must follow while using mobile application

1. Please don't uninstall application until survey completed
2. Agrigold document captured each image should contain
 - Customer Number
 - Customer details
 - Amount details

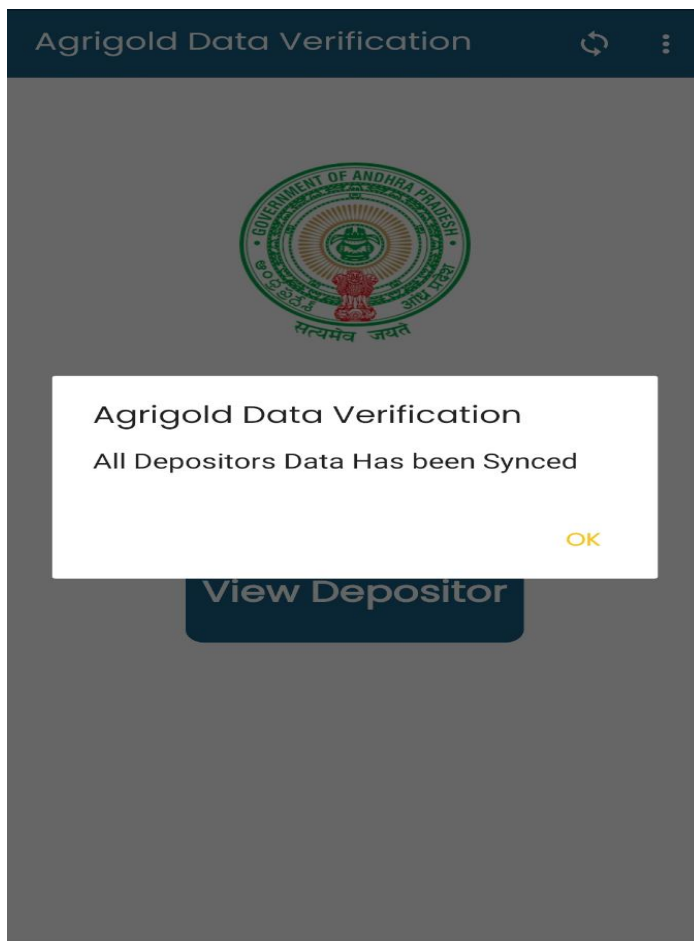
