## **ANNEXURE**

**(Govt. Memo.No.2030/BCW/C/2021 BC Welfare Dept, Dated:24.09.2021)**

**"Jagananna Chedodu" – Time Schedule for implementation of the financial assistance to Rajakas, Nayee Brahmins and Tailors belonging to all communities is as follows:**

**Step-1:** Communication of the list of beneficiaries from the CEO, APCFSS to the MPDOs/Municipal Commissioners concerned through the Executive Directors of District BC Service Coop. Societies along with guidelines on eligibility criteria.

**Timeline: 29.09.2021**

**Step-2:** Re-verification process by the Village/Ward Secretariats on whether the existing beneficiaries are living on profession of washing of cloths, Barber shops and Tailoring and also they are having shops etc. and identification of new eligible beneficiaries, based on the guidelines issued by the Government from time to time (Copies of the guidelines are enclosed along with survey format).

**Timeline: 30.09.2021 to 07.10.2021**

**Step-3:** Submission of eligible list of beneficiaries after re-verification and identification of new beneficiaries with the remarks of Social Audit teams to the MPDOs/Municipal Commissioner's concerned through online from the Village/Ward Secretariats for rectification of the lists at MPDO/Municipal Commissioner's offices, based on the remarks of the 3<sup>rd</sup> party social audit teams.

**Timeline: 08.10.2021 to 11.10.2021**

**Step-4:** Deletion of the in eligible names, as per the reports of the 3<sup>rd</sup> party Social Audit agency at Mandal/Municipality/Corporation and prepare the final list of beneficiaries.

**Timeline: 12.10.2021 to 14.10.2021**

**Step-5:** Preparation of the Village/Ward Secretariat wise list of eligible beneficiaries of the respective Mandal/Municipality/Corporation and furnish the same to the Village/Ward Secretariats for publication and calling objections if any.

**Timeline: 15.10.2021 & 16.10.2021**

**Step-6:** Submission of the final list of beneficiaries after publication from the Village/Ward Secretariats to the Mandal/Municipality/Corporation and onward submission to the Executive Director, DBCSCS Ltd., after cross checking at Mandal/Municipality/Corporation.

**Timeline: 17.10.2021 & 18.10.2021**

**Step-7:** Final scrutiny at District level at Executive Director, DBCSCS Ltd., and obtaining the approval of the eligible list of beneficiaries from the District Collectors concerned.

**Timeline: 19.10.2021 to 21.10.2021**


**Step-8:** Submission of final eligible list of beneficiaries to the CEO, APCFSS for preparation of bills (Corporation wise) online under intimation to the VC & Managing Director, APBCCFC.

**Timeline: 22.10.2021 & 23.10.2021**

**Step-9:** Transfer of the financial assistance through Direct Benefit Transfer (DBT) as per the schedule (date) to be finalized by the Government.
