Government after careful examination of the proposal of the MD, APSKWDC, Tadepalli, hereby approved the Time Schedule annexed to this Memo. for implementation of YSR Kapu Nestham Scheme meant for financial assistance to Women belonging to Kapu Community (Kapu, Baliya, Telaga and Ontari Sub-Castes) by granting Rs.75,000/- @ Rs.15,000/- per annum over a period of 5 years to financially empower the Kapu Women aged between 45 years and 60 years by enhancing their livelihood opportunities and living standards.

3. The Managing Director, AP State Kapu Welfare & Development Corporation, Tadepalli; the Director, GVWV & VSWS Department and all the District Collectors in the State of A.P. are therefore requested to take further course of action accordingly, without any deviation.
