Sub: BIE AP- IPE March 2023 – **Conduct of Environmental Education Examination on 17-02-2023** – Posting of Marks Online- Despatch of Answer Books– Certain Instructions issued – Reg.

It is informed that the Board of Intermediate Education, A.P. introduced Environmental Education as a compulsory qualifying subject for the Intermediate students from the Academic year 2006-07 onwards vide reference 1st cited.

Accordingly, the Board of Intermediate Education, A.P. desires to conduct the Environmental Education Examination for all the 1st year candidates (Regular and Private Attendance Exemption) of the academic year 2022-23 and also for the old candidates who were not qualified in the Environmental Education Examination from the year 2006-07.

Further, it is informed that Environmental Education Examination is a compulsory qualifying examination which is being conducted in First year Intermediate course only. The students have to submit project work and write the theory exam and obtain pass marks to get the pass certificate. If a candidate is not qualified in Environmental Education Examination, he/she will be considered as failed and will not be eligible to obtain Intermediate pass certificate.

Therefore, all the 1st year Intermediate students of the academic year 2022-23 will have to appear with first year Hall Ticket Number of March 2023 and the candidates who were **“not qualified”** in Environmental Education Examination relating to the academic years from 2006-07 to 2021-22 should appear with Second year Hall Ticket Number last appeared.

The attention of all the Principals of Junior Colleges in the state is invited to the references 1st to 4th cited, wherein clear instructions were issued for the conduct of Environmental Education Examination.

The Environmental Education Examination of IPE March 2023 will be held on 17-02-2023 from 10.00 AM to 1.00 PM (one day) as per the reference 5th cited. There is no change in syllabus and scheme of Examination/Valuation.

The practice of preparing question paper by the Junior Lecturers of concerned Junior colleges is dispensed with. The Question papers will be supplied online by the B.I.E., A.P. for conduct of Environmental Education Examination. However, the evaluation of answer scripts will be done by the Junior Lecturers of the nearby colleges.

Further, the following instructions should be followed meticulously for the conduct of Environmental Education Examination, 2023.

1. The students have to appear for both Theory Examination and Project work. Maximum Marks prescribed for Theory and Project Work are 60 and 40 respectively. A candidate should secure a minimum of 35 marks in both Theory and Project Work put together. Suppose, if a candidate appears for Theory Examination and is 'ABSENT' for Project Work or vice versa, he/she will not be declared as qualified in Environmental Education Examination. However, a candidate will be declared as qualified in this examination, though he/she secure 35% marks in Theory Examination and even 'Zero' in Project Work or vice versa. It is mandatory to qualify in Environmental Education Examination to get Intermediate Pass Certificate.
2. After completion of evaluation of the answer scripts the Principal of the College has to enter the marks both for Theory and Project work to each candidate in College login provided in the website <https://bic.ap.gov.in> as shown below.

Once the marks are confirmed there will be no provision of edit option for correction of marks.

The Principal should enter the marks online on or before 10 A.M on 20-02-2023. After that, the facility of posting/entry of marks online will be closed.

3. The Principal of the College has to despatch the consolidated Absentee Statement and Answer scripts along with print out copy of Marks posted in the website in sealed covers. The above may be submitted separately for General & Vocational streams.

4. The Principal should handover the above sealed covers to the RIOs concerned on or before 23-02-2023 and the RIOs in turn should submit them to the Dy. Secretary (Exams) concerned in the Head Office as detailed hereunder in a single consignment.

DESPATCH OF ANSWER BOOKS OF ENVIRONMENTAL EDUCATION EXAMINATION

1. The Answer Books of Environmental Education Examination of **General Intermediate Courses** should be packed in **LIGHT GREEN cloth cover** for easy identification. The sealed bundle of answer books should be handed over to the Regional Inspection Officer concerned. The RIOs should keep them under their safe custody till further orders. **Under any circumstances the answer book bundles should not be sent to the BIE Head Office.**
2. However, the Answer Books of Environmental Education Examination of **Vocational Courses** should be packed in **LIGHT YELLOW cloth cover** for easy identification. The sealed bundle should be handed over to the Regional Inspection Officer concerned along with the bundles of General Intermediate Environmental Education Answer Books without fail. The RIO should keep them under his/her safe custody till further orders.
3. **The Principals are instructed to allow the candidates who were not qualified in the Environmental Education examination earlier even though his / her name is not found in the award list. Their names with father's name should be included with the previous H.T No. in the blank award list provided and they may be allowed to write the Environmental Education examination.**

IMPORTANT NOTE:

DIFFERENT COLOURED CLOTHS, VIZ., GREEN FOR GENERAL and YELLOW FOR VOCATIONAL SHALL BE USED FOR PACKING. THE CLOTH SHOULD BE VERY LIGHT IN COLOUR AND THE ADDRESS OR THE OTHER INFORMATION SHOULD BE WRITTEN WITH DARK COLOURED MARKER.
