Ref:-Admissions guidelines communicated by the NESTS (National Education Society for Tribal Students) for the Academic Year 2023-24.

Attention of the Principals of EMRSs is invited to the subject and reference cited.

It is informed that, Gurukulam has decided to take up admissions into class XI by issuing a press note calling applications from the 10th passed out students and to conduct counseling at the District EMRS Convener points on merit basis duly following admission guidelines communicated by the NESTS, GoI, New Delhi.

The admission process for admissions into (19) EMRSs for 11th class in Science and Arts Groups are to be taken up for the academic year 2024-25. The details of institutions wise seats are as under:

In view of that, the Principals of the above (19) EMRSs are instructed to take the option of the group from the class X passed out students of their own EMR school and to promote them to class XI in the same institution duly following the guidelines

communicated by the NESTS. For the left over seats, applications shall be invited from the 10th passed out students of other board exams (SSC/ICSE/CBSE or its equivalent) irrespective of medium in the year 2024 only within the erstwhile catchment district/districts concerned. **No entrance test shall be conducted by the State for admission to class XI.** The candidates are selected on the basis of marks / CGPA obtained by them in class X in CBSE / State Board.

Reservations in Admission:

In accordance with EMRS Guidelines November 2020 & duly approved Note for the Cabinet Committee on Economic Affairs (CCEA) vide Ministry of Tribal Affairs letter No. 17011/03/2019- EMRS (Part — I) dated 05.12.2021, the below mentioned reservation criteria shall be followed for granting admissions in EMRSs:-

Procedure for admission in Class - XI:

No entrance test shall be conducted by State / UT EMRS Society for admission to class XI. The candidates are selected on the basis of marks / CGPA obtained by them in class X in CBSE / State Board.

EMRS Students:

The students declared Passed in class X by the CBSE/ State Board shall be automatically granted admission to class XI in the same EMRS. However, offer of stream viz. Science, Commerce, Humanities will be strictly on merit.

The merit list shall be prepared in the following criteria:

Science stream with Mathematics: Aggregate marks scored in class X + marks scored in science + marks scored in Mathematics.

Science stream without Mathematics: Aggregate marks scored in class X + marks scored in science.

Humanities Stream: All students declared passed in class X by CBSE / State Board.

Subject Combinations to be made available in various streams:

Science stream with Mathematics: English, Physics, Chemistry,

Mathematics & Computer Science / Biology / Hindi/ Regional Language/ Any other subject.

Science stream without Mathematics: English, Physics, Chemistry, Biology & Computer Science / / Hindi/ Regional Language/ Any other subject.

Humanities Stream: English, History and (2) subjects outs of Economics, Political science, Hindi, Regional Language or nay other subject.

Note:

A student may opt for 6th subject as an additional subject out of the subjects offered by an EMRS.

An EMRS may offer any subject as prescribed by the CBSE / State Board provided 15 or more students opt for the same. However, a student can also opt for any other subject (S) as prescribed by the CBSE / Sate Board even if the number of students is less than 15, provided he / she makes his / her own arrangement for study.

The State / UT EMRS Societies may exercise the option of running either all the three streams viz. Science, Commerce, & Humanities in class XI & XII or one or two streams in the EMRSs running in their State / UT depending upon local circumstances. The frequent change in streams is not allowed i.e. if a school opts for running (2) sections of Science Stream & one Section of Commerce stream in one year and then opts for all the three streams next year and then two streams following year.

If seats remain vacant in class XI even after admitting the children of EMRSs, then the admissions to non-EMRS children belonging to the reservation categories mentioned in reservation table at 2.4 I may be granted on the same criteria.

A student who was earlier not found eligible for admission to a particular stream may be allowed fresh admission to a particular

stream in class XI in the next academic session, if he / she improves his / her performance within one year from the same board.

Students of State Boards / ICSE/ NIOS for admission in class XI in Ekalavya Model Residential Schools:

The students of State Boards / ICSE/ NIOS may be considered for admission in class XI, if vacancies exist.

De Reservation: In case of insufficient turn out for admissions, the seats reserved for a particular reservation category shall be dereserved into other reservation categories as mentioned below:

Documentation:

The candidates who are provisionally selected for admission will have to submit the requisite documents, as demanded by the EMRS, at the time of admission for verification. The State/ UT EMRS Societies shall have to inform the candidates at the time of Registration & display of list of provisionally selected candidates about the documents required for admission.

However, a list of suggestive documents is mentioned as below:

Date of birth certificate issued by the authority competent to register births. This will include certificates from Notified Area Council / Municipality / Municipal Corporation extract about the date of birth from records of Village Panchayat, Military Hospital and service records of Defense personnel or Affidavit. The original certificate of date of birth should be returned to the parent after verification. Admissions up to class-

VIII may be granted without any school transfer certificate provided the child is otherwise eligible and his birth certificate has been

issued by a Govt. body or affidavit.

Aadhar Number / Card.

(It is pertinent to mention here that none of the child is to be denied admission on non-submission of Aadhar number. For the students with no Aadhar Number, the concerned EMRS where the child shall seek admission shall facilitate him / her in procurement of Aadhar Number).

Domicile / Reservation category certificate.

Service Certificate of the parents in case of Children of staff of EMRS / EMDBS / CES/ Doctors/ Paramedical staff of Government Hospital serving in the same block.

Disability certificate, if applicable.

Report card of the preceding class/ an Affidavit in case of the children who have not attended any school but studied at home.

Report of Medical Checkup of the Provisionally Selected Students is to be carried out by the EMRS.

Transfer certificate/ School Leaving Certificate from the previous school. But, at the time of registration the child is required to submit Bonafide Certificate from the school currently attending or self-declaration in case of not attending any school but studying at home/ NIOS Registration or Passing Certificate.

Any other documents required. (As decided by State EMRS Societies)

Further, no additional financial implications are to be borne by EMRSs/ NESTS/ MoTA as these children shall not be a part of EMRS Scheme. Since, no fee is prescribed in EMRS Scheme hence, the same shall not be charged from these students.

The number of seats for boys and girls will be equal. 3% of total available seats for admission will be horizontally reserved for differently able children as per the provisions of RTE act, 2009.

Transgender category students shall not be denied admission subject to fulfillment of eligibility conditions.

For point no.3, the proposed consolidated quota of reservation is 10% and no individual quota is allocated to any category mentioned therein. The State / UT EMRS Societies may be allowed to decide upon the percentage and priority of individual quota of the categories mentioned therein depending upon local situations & circumstances.

If a child belongs to more than one reservation category then he / she shall be allowed to avail the benefit of only one reservation category with the highest reservation percentage.

The merit list for each category shall be prepared separately on the basis of the marks achieved in class X.

The Principal is authorized to admit the children of staff in the respective EMRSs / EMDBSs/ CoE for Sports where the parent is working.

Further, the District Convener Principals of EMR Schools are hereby directed to obtain the promotion lists of students of EMR Schools from class X to class XI and take up the admissions through counseling for the **left over seats in class XI** as per the applied student's list communicated by the Gurukulam and circulate the file to the Project Officers of ITDAs / Joint Collectors in Non-ITDA Districts for approval of the merit lists and to conduct the counseling to complete the admission process tentatively in the 1st week of June 2024.

Responsibilities of the Convener Principal:

The Convener Principal shall issue a press note in the local papers regarding the admissions in EMR Schools with the approval of the Project Officer, ITDA / JC of Non-ITDA through Dy. Director (TW) / DTWO concerned.

All the Principals of Gurukulam institutions shall make necessary arrangements for uploading the applications of the students for admission into EMR Schools.

Registration form will also be placed in Website www.aptwgurukulam.ap.gov.in for downloading. Make necessary arrangements for issuing the directions to the Village Volunteers through the district administration for online the applications of the candidates and also fill the registration form.

Obtain the Registration form from each and every student who applied for admission into EMR Schools for class XI at the time of counseling.

While filling up the registration form at Gurukulam institution level (or) submitted by the Candidate at Gurukulam institution, the Principal shall verify the information filled in the Registration form with proofs, Age eligibility etc., and confirm whether the candidate is eligible or not for admission. "No postal correspondence will be

entertained".

The Convener Principal of EMRS shall coordinate with the Principals of other EMRSs in their district from time to time regarding online the applications, status etc., until completion of the last date for applying for class XI admission through online.

If any disputes in this regard shall bring to the notice of the Gurukulam for orders if not cleared at District level. Maintain transparency in the admissions process.

Further, all the Principals of Gurukulam institutions are instructed to give wide publicity and issue press note (In local press) inviting applications from the 10th passed out students.
