## 2. Minimum Educational Qualification / Qualifying Exam:

#### A: Category - Graduate Apprentices

- B.Tech / BE Degree (Full time Course) in Fire Technology & Safety Engineering with minimum 60% marks or equivalent CGPA from recognized Institute /College & University located in the state of Madhya Pradesh (Minimum marks relaxed up to 50% or equivalent CGPA for SC/ST/PwBD candidates and relaxation applicable for reserved posts only).
- B.Sc in Chemistry (Full time course) or equivalent like Industrial Chemistry, etc. with minimum 60% marks from recognized Institute /College & University located in the state of Madhya Pradesh (Minimum Marks relaxed up to 50% for SC/ST/PwBD candidates and relaxation applicable for reserved posts only).
- B.Com (Full time course) with minimum 60% marks from a from recognized Institute /College & University located in the state of Madhya Pradesh (Minimum Marks relaxed up to 50% for SC/ST/PwD candidates and relaxation applicable for reserved posts only)

#### B: Category - Diploma Apprentices

- Diploma in Engineering (Full time course) in the respective discipline with minimum 60% marks or equivalent CGPA from State Board of Technical Education/recognized Indian University located in the state of Madhya Pradesh (Minimum Marks relaxed up to 50% for SC/ST candidates).
- 3. Age: 18-27 years as on 1st January 2023 for general/unreserved candidates. For SC/ST/PWBD, age relaxation will be + 5 years. For OBC (NCL), the relaxation will be +3 years.
- 4. Reservation of Vacancies: Guidelines under the Apprenticeship Act on the reservation for SC/ST/OBC will be followed. Those who are claiming reservation under SC/ST/OBC shall provide certificate as per the standard format prescribed by the Government, failing which their claim for Category will be considered as "General" category only. Candidates claiming reservation under OBC category should bring OBC certificate (Non-Creamy Layer) as per Govt. prescribed format from the certificate issuing authority of Tehsildar. Applicable certificates in original need to be produced at the time of interview.
- 5. Duration of Training: The duration of Apprenticeship training will be for a period of one year.
- 6. Previous Training Experience: Candidates who have already undergone or are currently undergoing Training under the Apprenticeship (Amendment) Act 1973, and/or having one year of experience are not eligible to apply.
- 7. Selection Procedure: The candidates will be shortlisted for Personal interview in order of merit based on marks/CGPA obtained in the qualifying exam. The final selection of the candidates will be based on the cumulative performance in qualifying exam and personal interview.

Only those candidates are eligible to apply, who have done their Diploma/Graduation from colleges located in the state of Madhya Pradesh. Preference will be given to the candidates who are residents of District Sagar (M.P)
