Upper age relaxation of 5 years for SC/ST/PWD and 3 years for OBC candidates is as per government provisions /rules.

**II. Previous training/ experience:**

Candidates who have already undergone or are currently undergoing apprenticeship under Apprentices (Amendment) Act 1973, and/or having one year or more experience are **not eligible to apply**.

**III. Monthly Stipend:** 9000/-per month for Graduates (Technical and Non-technical) and 8000/- per month for diploma holder.
