3. **PAY & ALLOWANCES:**

Consolidated remuneration as per Medical Administration, HQRS Office Memorandum No. Z-17/11/1/2007/Med.IV(Pt. File) dated 13.04.2022 (other than retired Army Medical Teachers) as on date in different categories is as under:

- i) In addition to the pay above, the Medical Officers will be entitled for transport allowances with DA on transport allowance as per rules. DA on transport allowances will be revised from time to time as per rules.
  - ii) The amount of remuneration for Medical Officers will be revised automatically in accordance with proportionate change in rate of pay and allowances of equivalent category of employees at regular intervals as per Govt. policies. Accordingly, whenever there is revision in rate of Dearness Allowance, the same shall be made effective from the date of notification of Govt. orders. However, arrears of pay & allowances shall not be admissible for any rate revision with retrospective effect.
- a) No other allowances will be paid in addition to the consolidate remuneration.
  - b) No Private practice is allowed during the tenure of service in ESIC.
  - c) Retirees from Central/State Govt/PSU from the equivalent posts are eligible to apply .Persons working in recognized/approved Private Medical Institutions fulfilling eligibility criteria for the post may also apply.
  - d) The candidates have to attach the self-attested copies of all the relevant certificates/testimonials for support of date of birth, category, sub-category i.e. educational qualification, teaching experience, paper publications, Pension Payment Order(PPO),etc. with the application form and have to produce originals thereof at the time of interview.

4. **TERMS OF CONTRACT:**

- (a) **For Associate Professor/Assistant Professor:** -Selected candidates shall be appointed on purely contractual basis for a period of three year at the outset, and may be extended for a period of two years. The maximum tenure for such engagement will not exceed five years or 70 years of age of the faculty, whichever is earlier, in accordance to ESIC HQRS memorandum L-11/12/3/2018/Corporate Cell/ME Cell (PF)/288 dt. 28.10.2020. Candidates completing 5 years of contractual tenure will not be entitled for gratuity or any other pecuniary benefits.

- (d) Income and Asset and certificate from issuing Authority as per DOPT letter no. 36039/1/2019-Estt(Res) dated 31<sup>st</sup>January, 2019 must be submitted for the reservation for EWS Category.
- (e) Caste Certificate for SC/ST & OBC candidates. OBC Certificate as per Central Govt. Performa (not more than one year old) from the date of Interview.

- (g) The superannuated AFMS Medical Teachers are required to submit Equivalent teaching experience certificate issued by DGAFMS for retired Army Medical Teachers at the time of Interview.

6. **Selection Procedure:**

- a) The selection will be made on the basis of performance of the candidate in interview before the selection Board.
- b) Selected candidates will have to join immediately after receipt of offer of Appointment.
- c) Result will be displayed on web-site.

**General Conditions:-**

8. As per ESIC HQRS office Memorandum No. L-11/12/3/2014/PG-Basai/Vol-II/MEC(PF) dated 11.09.2020:
  - a) Candidates with eligibility for a higher post i.e. Associate Professor would be permitted to be interviewed against a lower post i.e. Assistant Professor.
  - b) In event of selection of such candidates, the candidates in the cadre of Associate Professor/Assistant Professor would be considered for placement with suitable up-gradation of the lower post as per eligibility; and recommendation of the selection board.
  - c) The up-gradation would be temporary and limited to the tenure of the teaching faculty/until the appointment of regular incumbent in the lower post.
