9. Order of Preference.

(a) First preference may be given to those candidates who have represent in an International Competition with the clearance of the Department of Youth Affai and Sports.

(b) Next preference may be given to those who have represented a State / UT in the Senior or Junior level national Championships organized by the National Sports Federations recognized by Department of Youth Affairs & Sports or National Games organized by Indian Olympics Association and have won medals or positions upto 3rd place. Between the candidates participating in Senior and Junior National Championshos/ Games, the candidates having participated and won medal in Senior nship should be given preference.

(c) Next preference may be given to those, who have represented a University in an Inter University competition conducted by Association of Indian Universities / University Sports Board and have won medals or positions upto 3th place in finals.

(d) Next preference may be given to those who represented a State / Union Territory University / State Schools Teams but could not win a medal or position, in the same order of preference.

(e) Next preference may be given to those who have represented the State Schools in National sports / games for Schools conducted by the All India School Games Federation and have won medals or positions upto 3rd place.

(f) Next preference may be given to those, who have been awarded National Av ysical efficiency under National Physical Efficiency Drive.

(g) Irrespective of levels of participation and medal won, a Field Trial in respective sport vill be carried out before final selection.

10. Selection Process.
