- b. The contractual appointment would be on full time basis and the appointed person will not be permitted to take up any other assignment during the period of engagement with

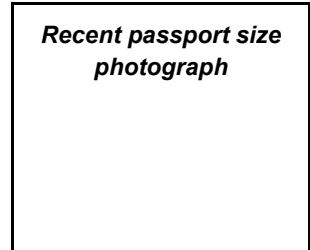
- the Ministry. As the post is temporary in nature and purely contractual, in no case any request for promotion or absorption as permanent employee shall be entertained.
