E. CENTRE OF EXAMINATION:

Written/Skill test etc shall be conducted at NIFT Campus, Ompura, Budgam, J&K.

F. SCHEME OF EXAMINATION:

The selection of the candidate shall be purely on merit list. The Merit list will be drawn on the basis of Written-Test / Skill-Test (wherever applicable). Detailed syllabus/scheme of Written Test/ Skill Test for all positions shall be notified separately.

G. GENERAL TERMS & CONDITIONS:

- 1. Candidates seeking age relaxation must ensure that they are entitled to such relaxation as per eligibility condition prescribed in the Advertisement.
- 2. Candidate shall be personally responsible for filling the details in the application form and the information/ details furnished by the candidate shall be treated as final for the purpose of determining the eligibility /claims of the candidates.
