**Academic Qualifications:**

Civil Asst. Surgeon Specialists : Post Graduate Degree/diploma in concerned specialties from the institution recognized by MCI. Preference will be given to Degree holders.

Civil Asst. Surgeon GDMOs : MBBS from the institution recognized by MCI

**Remuneration:**

a) Civil Asst. Surgeon Specialists : Rs.1,00,000/- (Rupees One lakh only) per month.

b) Civil Asst. Surgeon GDMOs(MBBS) : Rs.52,351/- per month.

**Method of Recruitment:**

- a. Total marks are 100 of which 90 marks will be allotted basing on the marks obtained in qualifying examination and 10 marks will be awarded for weightage i.e from year of completion/passing of the qualifying examination upto a maximum of (10)years with 1 mark per each year upto a maximum of 10 marks.
- b. Merit list will be prepared based on the marks obtained with above criteria and displayed on the office Notice Board.
- c. Selection list will be prepared from the finalized merit list duly following the rules of reservations etc., The Rule of reservation to local candidates is applicable as per Presidential order.
- d. Doctors: Post Graduate degree / Diploma duly registered from Medical council of India. 1st preference will be given to Post Graduate Degree holders based on their PG marks.
- e. Applications submitted without the copies of relevant certificates and with incomplete information will not be considered for selection and liable for rejection.
- f. The recruitment has to be on contract basis and the contract is initially for a period upto 31.03.2022. All guidelines to recruit the contract employees as prescribed by Govt. from time to time have to be followed.
- g. The decision of District Selection committee, Nalgonda under the chairmanship of the District Collector, Nalgonda regarding selection will be final and also the right to cancel the notification at any time without assigning any reasons thereof.
- h. Appointment shall be subject to Medical Fitness & verification of certificates of Education qualifications/MCI registrations.
- i. No TA/DA will be paid for appearing in the interview.

**General conditions:**

- a. The appointment for above posts on contract basin is purely on temporary basis and is able to be terminated at any time without any notice or assigning any reason thereof
- b. Contract period will be for one year from the date of commencement of agreement or from the date of reporting
- c. This contract appointment does not confer any right for regular appointment.
- d. They are only eligible for Casual Leaves as per rules per year and 120 days of Maternity leave for women without any pay and they are not eligible for any kind of Leave like Eared Leave, Half Pay Leave or Commuted Leave and in case of unauthorized absence for more than one month, their services will be terminated without any notice.
- e. The temporary services for the above posts on contract basis do not qualify for any pensionery benefits.
- f. That he/she has to discharge the duties for the above posts in the institution, to which he/she is posted, to the entire satisfaction of the superiors and incase of any default, he/she will be liable for termination without any notice.
- g. That he/she has to maintain absolute integrity and devotion to his/her duties

- h. If the candidate is willing to resign, he/she should submit one month prior notice in advance, to the undersigned.
- i. That he/she will not be transferable from the place of posting to any other place during the period of contract. However, keeping in view of Medical emergency. Employer has right to shift his/her services, wherever is required, for administrative convenience
- j. That during their contract period, the original certificates will remain under the custody of this office till the date of completion of contract.
- k. That he/she has to execute an agreement bond in the format on a non judicial stamp paper worth Rs.110/- agreeing to the above terms and conditions, from the date of reporting for duty concerned.
