No candidate will be entertained after 10.30 A.M.**
2. Candidates belonging to UR/OBC category have to deposit Demand Draft (Non-Refundable) of Rs. 300/- in favor of "ESI FUND ACCOUNT NO – 1" payable at New Delhi at the time of interview. SC/ST candidates have to deposit a Demand Draft (Non-Refundable) of Rs. 75/-. While PWD/Female candidates have exempted for payment of fee.
3. Candidates claiming reservation/age relaxation on ground of belonging to the OBC should submit the community certificate as prescribed by GOI, DOPT OM No. 36012/12/22/93-ESTT. (SCT) dated 08/09/93 which is modified by GOI DOPT OM No. 36033/3/2004(Res.) dated 09/03/2004 and time to time failing which the benefit of reservation/relaxation will not be given or their application shall be rejected. The OBC Certificate should be latest and not prior to one year from the date of interview.
4. Candidates seeking reservation benefits under SC/ST/OBC/EWS category must produce original certificates in the prescribed format of Govt. of India.
5. **The selected candidate for the post of Senior Residents (for 3 year,1 year), Contractual Specialist -3 year and Part Time Super Specialist-1 year will have to furnish a DD of an amount of Rs.10,000/- (Rs.
