Service Weightage marks will be considered, when the service certificate was signed by the concerned Medical Superintendent/ Medical Officer of that DH/AH/CHC along with countersignature by the concerned DCHS, DSH /DM&HO/Superintendent GGH/GMC/Concerned District Head Officer whichever is applicable and also enclose attested copy of appointment order compulsorily.
- If any service certificate submitted without countersignature from the concerned district authorities & Xerox copy of appointment orders that certificate will not be considered for weightage marks.
- 10. The Staff who are claiming weightage marks, they shall not be removed from service on any disciplinary grounds/adverse remarks/Un authorized absence.
