**DIRECT RECRUITMENT TO THE POST OF FOREST BEAT OFFICER AND ASSISTANT BEAT OFFICER  
IN A.P. FOREST SUBORDINATE SERVICE**

**(GENERAL / LIMITED RECRUITMENT)**

**PARA – 1:**

- 1.1. Applications are invited through online mode for recruitment to the post of Forest Beat Officer and Assistant Beat Officer in A.P. Forest Subordinate Service for a total of 691 vacancies (256 + 435) including Meritorious Sports person (MSP) vacancies for candidates within the age group of 18 - 30 years as on 01.07.2025.
- 1.2. Regarding vacancies reserved for Meritorious Sports persons (MSP):
  - a) The Vice Chairman and Managing Director, Sports Authority of Andhra Pradesh (SAAP) will issue a public notification in leading newspapers across the State, inviting the applications from eligible meritorious sports persons for vacancies reserved under MSP quota, in accordance with G.O. Ms.No.47, General Administration (Services-D) Department, dated: 19/04/2025.
  - b) The selection of eligible meritorious sports persons under the three percent (3%) sports quota (horizontal reservation) will be made without a written examination, based on the final approved merit list communicated by the State Level Committee (SLC) to the APPSC. This list shall be valid only for this specific notification.
  - c) The APPSC will integrate the final merit list of MSP candidates communicated by the State Level Committee (SLC) for implementing the horizontal reservation as per rules.
- 1.3. Candidates shall apply online through the Commission's Website <https://psc.ap.gov.in> The application submission window will be opened **from 16/07/2025 to 05/08/2025 up to 11:59 (midnight)**.
- 1.4. Candidates must login to the Commission's Website using their registered One Time Profile Registration (OTPR) number. If applying for the first time for any post notified by A.P.P.S.C., the candidate must register their bio-data through One Time Profile Registration (OTPR) at <https://psc.ap.gov.in> Upon registration, a user ID will be generated and sent to the candidate's registered mobile number and email ID.
 

**Note:** i. One Time Profile Registration (OTPR) is not considered an application for any post.

ii. Applicants are advised to retain their registered mobile number and Email ID to receive OTP/SMS and communication updates.

iii. SC Sub-classification is applicable. SC applicants must clearly specify their Group: SC (Group-I), SC (Group-II) or SC (Group-III).
- 1.5. As per G.O.Ms.No.39, General Administration (Ser.A) Department, dated: 26.03.2019, if the number of applicants exceed 200 times the number of vacancies, the Commission will conduct a Screening Test. Candidates will then be shortlisted for the Main Examination as per merit in a ratio decided by the Commission in accordance with G.O.Ms.No.5, General Administration (Ser-A) Dept., dt: 05.01.2018.
- 1.6. Both the Screening and Main Examination will be objective type and held in offline (OMR based) mode. **The dates for both Screening and Main Examination will be announced separately.**
- 1.7. Applicants must regularly visit the Commission's website to stay updated throughout the recruitment process. The Commission's website will serve as the sole source of the official communication. No individual correspondence will be entertained under any circumstances.
- 1.8. HALL TICKETS for both the Screening and Main Examination will be hosted on Commission's Website. Instructions for downloading Hall Tickets will be published on the Website.

1.9. All eligible and interested candidates must apply online after satisfying themselves about the terms and conditions of this recruitment. Applications submitted through any mode other than online **will not be entertained**. Submission of the online application implies that the candidate has read and agrees to abide by the terms and conditions laid out in this notification.

2. As per G.O.Ms.No.277, GA (SC & ST CELL .B) Dept., dated: 22.03.1976 and G.O.Ms.No.23, Backward Class (Welfare) Dept., dated: 18.03.1996, the Carried Forward vacancies to be filled first by a relevant community candidate in succeeding recruitment.
3. The number of Meritorious Sportsperson (MSP) vacancies and SC Group-wise vacancies will be informed in Addendum. The MSP vacancies will be filled as per G.O.Ms.No.04, Youth Advancement, Tourism & Culture (Sports & Youth Services) Dept., dt:19/04/2025 read with G.O.Ms.No.47, General Administration (Services.D) Dept., dt: dt:19/04/2025.

**PARA-2: ELIGIBILITY:**

- i. He / She is of sound health, active habits and free from any bodily defect or infirmity rendering him / her unfit for such service;
- ii. His / Her character and antecedents are such as to qualify him/her for such service;
- iii. He /She possesses the academic and other qualifications prescribed for the post; and
- iv. He/ She is a citizen of India.

Provided that no candidate other than a citizen of India may be appointed except with the previous sanction of the State Government and except in accordance with such conditions and restrictions as may be laid down. Such sanction shall not be accorded unless the State Government is satisfied that sufficient number of citizens of India, who are qualified and suitable are not available.

**PARA-3: EDUCATIONAL QUALIFICATION:**

The candidate should possess the prescribed academic qualification as on the date of this notification. **The date of this notification** shall be the crucial date for calculating the experience including the practical experience. **In respect of other than prescribed Educational Qualification, claiming equivalence, the decision of the concerned Department (Unit Officer) shall be final.**

**Note:** If the applicant possesses an equivalence of qualification other than prescribed qualification in the Commission's notification, applicant should produce a copy of the Government Orders to the Commission in advance within 10 days of last date for submitting applications, failing which their application will be rejected.

**Note:**

1. Candidates must obtain physical measurement certificate issued by Medical Officer not below the rank of Civil Assistant Surgeon, which will be furnished to the Commission at appropriate time.
2. Based on merit in Main written examination, those who are qualified in Walking Test and Medical Examination, the candidates will be shortlisted for Computer Proficiency Test. No candidate shall be eligible for appointment unless he/she qualifies the Computer Proficiency Test in terms of G.O.Ms.No.26, G.A. (Ser-B) Dept., Dt: 24.02.2023.

**PARA- 4: RESERVATIONS:**

- 4.1. There will be Vertical Reservations in direct recruitment in respect of Scheduled Tribes, Scheduled Castes, Backward Classes and Economically Weaker Sections and Horizontal Reservations in respect of Women, Ex-Servicemen and Meritorious Sports Persons (MSP) as per Rule 22, 22(A) and 22(B) of A.P. State and Subordinate Service Rules, 1996 as amended vide G.O.Ms.No.77, G.A. (Ser-D) Dept., Dt: 02.08.2023, G.O.Ms.No.03, G.A. (Ser-D) Dept., Dt: 17.01.2024, G.O.Ms. No.7, SW (CV) Dept., Dt: 18.04.2025, G.O.Ms.No.46, GA (Ser-D) Dept., Dt: 19.04.2025, G.O.Ms.No.4, YAT&C (Sports & Youth Services) Dept., Dt: 19.04.2025, G.O.Ms.No.47, GA (Ser-D) Dept., Dt: 19.04.2025 & G.O.Ms.No.48, GA (Ser-D) Dept., Dt: 20.04.2025.

**NOTE: The candidates belonging to SC, ST, BC, & EWS and who avail upper age relaxation will also be considered for open category vacancies.**

- 4.2. There shall be Reservation to Women horizontally to an extent of 33 1/3% in terms of Rule 22, 22 (A) and 22 (B) of A.P. State and Subordinate Service Rules, 1996 as amended vide G.O. Ms. No. 77, GA (Ser-D) Dept., Dt:02.08.2023, G.O.Ms.No.03, G.A. (Ser-D) Dept., Dt: 17.01.2024, G.O.Ms. No.7, SW (CV) Dept., Dt: 18.04.2025, G.O.Ms.No.46, GAD, Dt: 19.04.2025 and G.O.Ms.No.48, GA (Ser-D) Dept., Dt: 20.04.2025.
- 4.3. **No reservation shall be made for Persons with Benchmark Disability (PBD) for these posts as per the Service Rules in G.O. Ms. No. 88, EFS & T (For.IV) Dept., dated: 19.07.2000.**
- 4.4. With regard to reservation of Meritorious Sportspersons, the rules issued vide G.O.Ms.No.4, Youth, Advancement, Tourism and Culture (Sports & Youth Services) Dept., dated: 19.04.2025, read with G.O.Ms.No.47, GA (Ser.D) Dept., Dt:19.04.2025 will be followed. **In the event of non-availability of any eligible Meritorious Sportsperson for a particular post earmarked to be filled under the three percent (3%) horizontal reservation for the meritorious sportspersons, such post shall stand lapsed.**
- 4.5. Reservation to BC-E group will be subject to the adjudication of the litigation before the Hon'ble Courts including final orders in Civil Appeal No: 2628-2637 of 2010 in SLP(C). No. 7388-7397 of 2010, dated: 25/03/2010 and orders from the Government.
- 4.6. The candidates claiming status of non-creamy layer of Backward Class have to obtain a Certificate in terms of G.O. Ms. No. 3, Backward Classes Welfare (C-2) Department, Dated 04.04.2006 read with G.O. Ms. No. 26, Backward Classes Welfare(C) Department, Dated 09.12.2013 regarding their exclusion from the Creamy Layer from the competent authority (Tahsildar) and produce the same at appropriate time of verification. In case of failure to produce the same on the day of verification, the Candidature will be considered against Open Competition, if he / she is otherwise eligible in all aspects.
- 4.7. Economically Weaker Sections means the persons who are not covered under existing scheme of reservations for the SCs, STs and Socially and Educationally Backward Classes and whose gross annual family income is below Rs.8.00 lakh. Only such persons are identified as Economically Weaker Sections for the benefit of reservations. The persons seeking the benefit of reservation under EWS category shall obtain the necessary EWS Certificate **for the financial year prior to the year of application** issued by the Tahsildar concerned and produce at an appropriate time to the Commission as per G.O.Ms.No:73, GA (SER-D) Dept,Dt:04-08-2021.
- 4.8. In the case of candidates who claim the benefit of reservation or relaxation from upper age limit on the basis of Caste/Tribe or Community/Category the basic document of proof of Community/Category will be the Certificate issued by the Revenue Authorities not below the rank of Tahsildar in the case of SC/ST/EWS and Non Creamy Layer Certificate issued by the Revenue Authorities in the case of Backward Classes. The list of Caste/Tribe/Community is as incorporated in Schedule-I of above Rules. The list is also appended at Annexure -IV. The candidates have to produce proof of the community claimed in their application at all stages of selection along with the certificates relating to Educational Qualifications and local status certificates etc. Subsequent claim of change of community will not be entertained.
- 4.9. Caste & Community: Community Certificate issued by the competent authority in terms of G.O. Ms No. 58, SW (J) Dept., dt.12/5/97 should be submitted at appropriate time. As per A.P. State and Subordinate Service Rules, Rule-2(28) Explanation: In so far as claiming for SC reservation is concerned, No person who professes a religion different from Hinduism shall be deemed a member of Schedule Caste. However, Scheduled Caste converts to Buddhism are deemed to be Scheduled Caste. **BCs, SCs, STs & EWS belonging to other States are not entitled for reservation.**

- 4.10. As per G.A (Ser-D) Department letter No. 18030/1/Ser-D/2018, Dated 23-02-2018 clarified that the explanation under rule-2(16) of A.P State and Subordinate Service Rules, 1996 that the persons serving in the Armed Forces of the Union, who on retirement from service would come under the category of Ex-Servicemen, may be permitted to apply for Re-Employment one year before the completion of the specified terms of engagement in the Armed Forces of the Union. Further, as per the Government of India instructions issued in the Memo No. 36034/02/1991-Estt.(SCT), Dated:03-04-1991 and the Memo No.36034/03/2013-Estt., (Res.) Dated:25-02-2014, a candidate working in Armed Forces would become eligible for applying civil posts only when he completes the prescribed period of Army service within a year from the last date for receiving application in connection with Special Recruitment/Examination etc prescribed by the Competent Authority.
- 4.11. Two percent (2%) reservation shall be provided to Ex-servicemen. Out of two percent (2%), one percent of posts shall be given to Women and if no eligible women Ex-servicemen candidate is available, two percent (2%) of reservation shall be filled up with men. **If no eligible Ex-servicemen are available, then the 2% or any shortfall of 2% of posts stand lapse as per G.O.Ms.No.77, G.A (Ser-D) Dept., Dt: 02.08.2023.**
- 4.12. Horizontal Reservation cuts across vertical reservation (in what is called inter-locking reservation) and persons selected against the quota for Ex-Servicemen / Meritorious Sports Persons have to be placed in the appropriate category viz. SC / ST / BC / EWS / Unreserved depending upon the category to which they belong in the roster meant for reservation of SCs/STs/BCs/EWSs as per G.O. Ms. No.77, G.A. (Ser-D) Dept., Dt: 02.08.2023, G.O.Ms.No.4, YAT&C (Sports & Youth Services) Dept., Dt: 19.04.2025, G.O.Ms.No.47, GA (Ser-D) Dept., Dt: 19.04.2025 & G.O.Ms.No.48, GA (Ser-D) Dept., Dt: 20.04.2025.
- 4.13. **The reservations and relaxations to different categories/communities are applicable only in case of availability of vacancies to the respective category/community as announced through this notification.**

#### **PARA - 5: RESERVATION TO LOCAL CANDIDATES:**

- 5.1. The specification of a post is determined by the concerned Department with reference to both vertical and horizontal reservations as well as local reservation. The reservations are specified through the indent by the concerned department and the general criteria with regard to reservations are given below.
- 5.2. Reservation to the Local candidates is applicable as provided in Article 371-D as per G.O.Ms.No.674, G.A (SPF-A) Department, dated.20.10.1975 and rules as amended from time to time and as in force on the date of notification. The candidates claiming reservation as Local candidates should obtain the required Study Certificate(s) (from IV Class to X Class or SSC) OR Residence Certificate in the proforma prescribed for those candidates who have not studied in any Educational Institutions as the case may be. The relevant certificates with authorized signature shall be produced as and when required.
- 5.3. As per G.A (SPF & MC) Department Letter No. 5352/SPF & MC/2018, Dated:01-02-2018 clarified the A.P. Local Status of the candidate for direct recruitment with reference to the provisions of paragraph 7 of the Presidential Order,1975 that the 2 year period of study (9<sup>th</sup> & 10<sup>th</sup> class) under National Integration Scheme at outside the State of A.P. and he/she studies from 4<sup>th</sup> class to 8<sup>th</sup> class in Jawahar Navodaya Vidyalaya in A.P. District and thereafter migrated to Navodaya Schools outside the state of A.P. under National Integration Scheme may be treated as the study in Navodaya Schools in A.P. in which he/she been admitted originally for the purpose of determining the local candidature of the candidate.

#### **PARA -6: DEFINITION OF LOCAL CANDIDATE:**

- 6.1. A local candidate has been defined in G.O.Ms.No.674, General Administration (SPF-A) Department, dated: 20.10.1975 "LOCAL CANDIDATE" as follows:
- "Local Candidate:- (1) A candidate for direct recruitment to any post shall be regarded as a local candidate in relation to a local area.
- (a) in cases where a minimum educational qualification has been prescribed for recruitment to the post.
- (i) "if he /she has studied in an educational institution or educational institutions in such local area for a period of not less than four consecutive academic years ending with the academic year in which he /she appeared or, as the case may be, first appeared for the relevant qualifying examination; or

(ii) where during the whole or any part of the four consecutive academic years ending with the academic year in which he /she appeared or as the case may be, first appeared for the relevant qualifying examination he/she has not studied in any educational institution, if he /she has resided in that local area for a period of not less than four years immediately preceding the date of commencement of the qualifying examination in which he /she appeared or as the case may be, first appeared.

(b) In cases where no minimum educational qualification has been prescribed for recruitment to the post, if he/she has resided in that local area for a period of not less than four years immediately preceding the date on which the post is notified for recruitment.

Explanations:- For the purpose of the paragraph.

(i) educational institution means a University or any educational institution recognized by the State Government, a University or other competent authority;

(ii) relevant qualifying examination in relation to a post means;

(a) the examination, a pass in which the minimum educational qualification is prescribed for the post;

(b) the Matriculation examination or an examination declared by the State Government to be equivalent to the Matriculation examination; whichever is lower; and

(iii) In reckoning the consecutive academic years during which a candidate has studied, any period of interruption of his /her study by reason of his /her failure to pass any examination shall be disregarded.

(iv) the question whether any candidate for direct recruitment to any post has resided in any local area shall be determined with reference to the places where the candidate actually resided and not with reference to the residence of his /her parents or other guardian (Vide G.O.Ms.No.168, G.A. (SPF.A) Dept., dt.10-3-77).

(2) A candidate for direct recruitment to any post who is not regarded as a local candidate under sub paragraph (1) in relation to any local area shall.

(a) in cases where a minimum educational qualification has been prescribed for recruitment to the post.

(i) if he /she has studied in educational institutions in the State for a period of not less than seven consecutive academic years ending with academic year in which he /she appeared or as the case may be, first appeared for the relevant qualifying examination, be regarded as a local candidate in relation to

(1) Such local area where he /she has studied for the maximum period out of the said period of seven years; or

(2) where the periods of his /her study in two or more local areas are equal, such local areas where he /she has studied last in such equal periods;

(ii) if during the whole or any part of the seven consecutive academic years ending with the academic years in which he /she appeared or as the case may be first appeared for the relevant qualifying examination, he/she has not studied in the educational institutions in any local area, but has resided in the State during the whole of the said period of seven years, be regarded as a local candidate in relation to

(1) such local area where he /she has resided for a maximum period out of the said period of seven years; or

(2) where the periods of his/her residence in two or more local areas are equal, such local areas where he /she has resided last in such equal periods;

(b) In cases where no minimum educational qualification has been prescribed for recruitment to the post, if he/she has resided in the State for a period of not less than seven years immediately preceding the date on which the post is notified for recruitment, be regarded as a local candidate in relation to

(i) such local area where he /she has resided for the maximum period out of the said period of seven years; or

(ii) where the periods of his /her residence in two or more local areas are equal such local area where he/she has resided last in such equal periods "(G.O.Ms.No.168, dated 10-3-1977).

6.2. Single certificate, whether of study or residence as stipulated in G.O.Ms.No.674, General Administration (SPF-A) Dept., dated: 20.10.1975 would suffice for enabling the candidate to apply as a "LOCAL CANDIDATE".

- 6.3. Residence certificate will not be accepted, if a candidate has studied in any Educational Institution up to S.S.C. or equivalent examination. Such candidates have to produce study certificates invariably. The candidates, who acquired degree from open Universities directly without studying in any Educational Institution, only may submit residence certificate. Here Educational Institutions mean a recognized Institution by the Government / University/Competent authority.
- 6.4. Candidates are advised to refer provisions of the PRESIDENTIAL ORDER 1975 in this regard.
- 6.5. Candidates who migrated from Telangana to Andhra Pradesh between 2<sup>nd</sup> June, 2014 and 1<sup>st</sup> June, 2024 as per G.O. Ms. No. 161, General Administration (SPF&MC) Department, dated.27.12.2022 and as per terms laid down in Circular Memo No.4136/SPF & MC/2015-5, Dated.20.11.2017 and Circular Memo No.4136/SPF & MC/2015-17, Dated.27.12.2022 of Government of Andhra Pradesh shall obtain the Local Status Certificate from competent authority and produce at the time of verification.
- 6.6. **DEFINITION OF LOCAL SCHEDULED TRIBE CANDIDATE:**  
100% of posts in category of FBO/ABO are exclusively reserved for Local Scheduled Tribe candidates for the posts falling in scheduled Areas in the State as per G.O.Ms.No.93 Social Welfare (V) Dept., Dated: 22.04.1987 and G.O. Ms. No. 88, EFS & T (For.IV) Dept., dated: 19.07.2000. No other ST candidate is eligible for these posts other than Local ST candidates. **The Local ST candidate** as per G.O.Ms.No.3, Social Welfare (TW.EDN.II) Dept., Dated: 10-01-2000 is defined as **“The candidates belonging to the Scheduled Tribes notified as such under article 342 of the Constitution of India and the candidates themselves or their parents have been continuously residing in the scheduled areas of the Districts in which they are residents till to date since the 26<sup>th</sup> January, 1950.”** Therefore the ST candidates claiming LOCAL to the scheduled Area shall invariably verify themselves with reference to above definition of Local ST candidate and obtain a certificate issued by the Tahsildar in-charge of the Mandal to which they are local and the same shall be produced at the time of certificate verification. If the status of ST local candidate is found to be fraudulent or fake, the candidature shall be summarily rejected, besides other actions as per rules and procedures in force.

**PARA- 7: AGE:**

- 7.1. Minimum 18 years & Maximum 30 years as on 01/07/2025, as per G.O.Ms.No.37, GA (Ser-A) Dept., Dt.04/03/2025.
- N.B.:** No person shall be eligible if less than 18 years and is more than 30 years.

7.2. Age Relaxation is applicable to the categories as detailed below:

Note: 1. The age concession provided in General Rule 12 (1)(c)(iii) of the Andhra Pradesh State and Subordinate Service Rules shall not be applicable for direct recruitment to the posts included in class-A as per G.O.Ms.No.88, EFS & T (For.IV) Dept., dated:19.07.2000.

2. The age concession provided in General Rule 12 (1) (c) (i) and (ii) of the Andhra Pradesh State and Subordinate Service Rules to the persons in the Defense Services of Indian Union and the hole time Cadet Corps Instructors in the National Cadet Corps (NCC) for employment in Civil posts shall not apply to the recruitment to the posts included in class-A as per G.O.Ms.No.88, EFS & T (For.IV) Dept., dated: 19.07.2000.

**PARA - 8 HOW TO APPLY:**

**STEP-I:** The applicant desires to apply for the post shall login the Commission's Website with his/her registered OTPR number. Candidate applying for the first time for any notification has to first fill the OTPR application carefully to obtain OTPR ID. While filling the OTPR, the candidate has to ensure that the particulars are filled correctly. The Commission bears no responsibility for the mistakes, if any, made by the candidates. If candidates choose to modify they may do so by clicking the modify OTPR make the modification, save them and proceed to STEP-II.

**STEP-II:** The Applicant has to Login in the Commission's website with the User Name (OTPR ID) and the Password set by Candidate. After Login, the Applicant has to click on the "Online Application Submission" present in the bottom right corner of the Commission's website. The applicant now has to click on the Fill Application button against the notification number that he / she wants to apply.

**STEP-III:** After checking all the data and ensuring that the data is correct the applicant has to fill application specific data such as Local/Non Local status, White card details etc., which are also used to calculate the Fee. 3. Applicant shall note that the data displayed from OTPR at the time of submitting the application will be considered for the purpose of this notification only. Any changes made by the applicant in OTPR data at later date shall not be considered for the notification on hand.

**PAYMENT PROCESS:** The applicant has to check the basic details for calculation of the fee and age relaxation will be pre-populated from the OTPR data. The applicant has to verify all the details that are displayed. Once the payment form is submitted, the respective details (used for Calculation of fee and age relaxation) will not be altered in any stage of application processing. A. The Commission is not responsible, for any omissions made by the applicant in bio-data particulars while submitting the application form online. The applicants are therefore, advised to strictly follow the instructions given in the user guide before submitting the application.

B. All the candidates are requested to submit their application with correct data. It is noticed that some of the candidates are requesting for change in the data, after submission of the application. It is informed that such requests shall be allowed on payment of Rs.100/- (Rupees Hundred Only) for each correction. However changes are not allowed for Name, Fee and age relaxation. No manual application for corrections shall be entertained.

**PARA-9: (a) FEE:**

9.1. Applicant must pay Rs. 250/- (Rupees two hundred and fifty only) towards application processing fee and Rs 80/- (Rupees Eighty only) towards examination fee.

9.2. However, the following categories of candidates are exempted from payment of examination fee Rs.80/- only.

- iv) Applicants belonging to the categories mentioned above (except Ex-Servicemen) hailing from other States are not entitled for exemption from payment of fee and not entitled for claiming any kind of reservation.
- v) Candidates belonging to other States shall pay the prescribed fee of Rs.80/- (Rupees Eighty only), along with processing fee of Rs. 250/- (Rupees two hundred and fifty only). Otherwise such applications **will not be considered** and no correspondence on this will be entertained.

9.3. **b) Mode of payment of Fee:**

- i) The fee mentioned in the above paragraph is to be paid online using payment gateway using net banking/ credit card / debit card. The list of banks providing service for the purpose of online remittance of fee will be available on the website.
- ii) The fee once remitted shall not be refunded or adjusted under any circumstances. Failure to pay the examination fee and application fee (in non-exempt case) will entail total rejection of application.
- iii) IPOs / Demand Drafts are not accepted.
- iv) In case of corrections Rs.100/- per correction will be charged. **However changes are not allowed for name, fee and age relaxation.**

**PARA-10: SCHEME OF EXAMINATION:**

10.1. The Scheme & Syllabus for the Screening Test and Main Examination including Computer Proficiency Test (CPT) has been shown at **Annexure-II**.

10.2. Scheme is prescribed as per G.O.Ms.No.3, General Administration (Ser-A) Department, dated: 04.01.2019 and G.O.Ms.No.26, G.A. (Ser-B) Dept., Dt: 24.02.2023 for CPT.

10.3. As per G.O. Ms. No.235, Finance (HR-I, Plg & Policy) Dept., Dt. 06/12/2016, each wrong answer will be penalized with 1/3<sup>rd</sup> of the marks prescribed for the question.

- 10.4. As per G.O.Ms.No.5, General Administration (Ser-A) Dept., dated:05.01.2018, the Andhra Pradesh Public Service Commission is empowered to pick up candidates who obtain such minimum qualifying marks in Screening Test (Preliminary Examination) as may be fixed by the Commission at its discretion to the Main Examination in all direct recruitment examinations. The APPSC is further permitted to select candidates belonging to the Scheduled Caste or Scheduled Tribes or Backward Classes for Main Examination by applying relaxed standards in the Screening Test (Preliminary Examination), if the Commission is of the opinion that sufficient number of candidates from these communities are not likely to be eligible for main examination on the basis of general standard in Screening Test (Preliminary Examination) in order to fill up the vacancies reserved for them.

**PARA - 11: CENTRES FOR THE SCREENING TEST AND MAIN EXAMINATIONS:**

The applicant may choose the Test centre with three preferences. However the Commission reserves the right to allot the applicant to any centre of examination depending on the availability of the resources like centers.

**PARA-12: RESOLUTION OF DISPUTES RELATED TO QUESTION PAPER, ANSWER KEY AND OTHER MATTERS:**

12.1. **Invalidation of OMR Answer Sheet:**

**a. If any applicant fails to bubble or wrongly bubbles the Booklet Series in the OMR Answer Sheet, such Answer sheets are invariably invalidated as the answer sheets are valued by Optical Mark Reader. This stipulation is to avoid any sort of human interface in evaluation of the Scripts.**

**b. Tampering of OMR answer sheet by using whitener, eraser, blade and chalk powder etc., and also tampering of barcode by any means leads to invalidation.**

**c. No request for reconsideration of such rejected/invalidated cases will be entertained.**

- 12.2. The Commission would publish initial answer key(s) for the question paper(s) on its website after conduct of the examination. If the candidates have any objections with regard to the initial key / questions they shall have to file the objections within three days after publication of the initial key in the prescribed proforma available in the website. Any objection filed after expiry of specified time would not be entertained.

- 12.3. The objections received if any on initial key, would be examined by referring it to three subject experts and finalize the key as per the decision of the Commission. And the key so finalized shall be final and no further objections shall be taken into account.

- 12.4. The candidate shall pay Rs.100/- per objection raised by him/her against question/ initial answer key within the stipulated time and procedure as above. In case of genuine objections, which are sustained in the final analysis, the amount will be reimbursed to the candidate.

- 12.5. **The candidates can write the Essay Paper (Descriptive Type) either in Telugu or in English or in Urdu. The Essay question paper is set in English and translated into Telugu/Urdu Language. The remaining question papers (Objective) are set in English and translated into Telugu Language. English version will be considered as the authentic version for valuation purpose.**

- 12.6. With regard to situation where there is deletion of questions, if any, from any paper, scaling (proportionate increase) would be done for that particular part of the paper to the maximum marks prescribed for the paper and the marks would be rounded off to 2 decimals to determine the merit of the candidate.

- 12.7. ANSWER KEY: Answer key would be published on the website.

**PARA-13: NOTE ON IMPORTANT LEGAL PROVISIONS GOVERNING THE RECRUITMENT PROCESS:**

- 13.1. Vacancies: The recruitment will be made to the vacancies notified only. There shall be no waiting list as per G.O. Ms. No. 81, General Administration (Ser. A) Department, Dt: 22/02/1997, G.O.Ms.No.544, General Administration (Ser.A) Department, Dt: 04.12.1998 and Rule 6 of APPSC Rules of procedure. In any case, no cognizance will be taken by Commission of any vacancies arising or reported after the completion of the selection and recruitment process or the last date as decided by the Commission as far as this notification is concerned, and these will be further dealt with as per G.O. & Rule cited above. As per G.O.Ms.No:139, Finance HR (I) Planning Policy Dept., dt: 28/07/2016, Rule 7 of APPSC Rules of procedure regarding relinquished vacancies has been deleted.

- 13.2. The Recruitment will be processed as per this notification and as per the Rules and Instructions issued by the Government and also as decided by the Commission from time to time and in terms of A.P. Forest Subordinate Service Rules issued in G.O.Ms.No.93, Social Welfare (V) Dept., Dated: 22.04.1987, G.O.Ms.No.88, Environment, Forests, Science & Technology (For-IV) Department, dated: 19/07/2000, G. O. Ms. No. 12, Environment, Forest, Science & Technology (For-V) Department, Dated:17/02/2012, G.O.Ms.No.101, Environment, Forest, Science & Technology (SEC.V) Department, dated:15.10.2018, G.O.Rt.No.2495, General Administration (Ser-A) Dept., dated:28.11.2018, G.O.Ms.No.03, General Administration (Ser-A) Dept., dated:04.01.2019, G.O.Ms.No.09, Environment, Forests, Science & Technology (SEC.V) Department, dated:28.01.2019 and Special Rules / Adhoc Rules Governing the recruitment and other related GOs, Rules etc are applicable.
- 13.3. Rules: The various conditions and criteria prescribed herein are governed by the A.P. State and Subordinate Service Rules, 1996 read with relevant Special Rules applicable to any particular service in the departments. Any guidelines or clarification is based on the said Rules, and, in case of any necessity, any matter will be processed as per the relevant General and Special Rules as in force.
- 13.4. The Commission is empowered under the provisions of Article 315 to 320 of the Constitution of India read with relevant laws, rules, regulations and executive instructions and all other enabling legal provisions in this regard to conduct examination for appointment to the posts notified herein, duly following the principle of order of merit as per Rule 3(vi) of the APPSC Rules of Procedure read with relevant statutory provisions and ensuring that the whole recruitment and selection process is carried out with utmost regard to secrecy and confidentiality so as to ensure that the principle of merit is scrupulously followed.
- 13.5. District/Local: In terms of Para 4 of the G.O., A.P. Public Employment (Organization of Local Cadres and Regulation of Direct Recruitment) Order, 1975 (G.O.Ms.No.674, G.A. (SPF-A) Dept., dated: 20/10/1975) read with G.O.Ms.No.124, General Administration (SPF - A) Department, dated: 07/03/2002, Memo No.42005/Ser.D/2002-1 dated 28.08.2002 "The provisional list shall be divided into two parts. The first part shall comprise 20% of the posts consisting of combined merit lists of locals as well as non-locals and the remaining second part shall comprise the balance 80% of the posts consisting of locals only and the posts shall be filled duly following the rule of reservation".
- Note:** 1. 80% of posts reserved to local candidates and remaining 20% posts meant for both local and Non-local in plain area.  
2. 100 % of the posts in the notified scheduled areas of the State shall be filled only by local members of Scheduled Tribes of the relevant local areas.
- 13.6. The persons already in Government Service / Autonomous bodies / Government aided institutions etc., whether in permanent or temporary capacity or as work charged employees are however required to inform, in writing, to their Head of Office / Department that they have applied for this recruitment.
- 13.7. A candidate shall be disqualified for appointment, if he himself or through relations or friends or any others has canvassed or endeavored to enlist for his candidature, extraneous support, whether from official or non-official sources for appointment to this service.

#### **PARA-15: PROCEDURE OF SELECTION:**

- 15.1. **Appearance in all the papers of screening examination / Main examination / Physical examination / CPT are compulsory. Absence in any of the papers / examination will automatically render the disqualification of the candidature.**
- 15.2. The selection of candidates for appointment to the post will be made on the basis of merit in the Main Written Examination followed by Computer Proficiency Test (CPT).  
**Note:** The final selection shall be done from among the persons who have qualified in Physical tests (Walking Test and Medical examination) and CPT, based on the marks secured in written examination duly observing roster points and the bonus marks wherever applicable.

15.3. The standard for the examination and the cut off marks for various categories for selection shall be fixed by the Commission. However the candidates have to secure minimum qualifying marks to be shortlisted for selection against respective vacancies. The minimum qualifying marks on aggregate for the vacancies notified under different categories are as follows as per G.O.Ms.No.103, G.A. (Ser.A) Dept., dt.03.02.1967 and amendments from time to time.

- 1. Open Competition (OC), Ex-Servicemen & EWS: 40%
- 2. Backward Class: 35%
- 3. SCs & STs: 30%

N.B.: Mere securing of minimum qualifying marks does not confer any right to the candidate for being considered to the selection.

15.4. The claims of members of the Scheduled Castes, Scheduled Tribes, Backward Classes, Economically Weaker Section and Women as the case may be, shall also be considered for the vacancies earmarked for Open Competition, which shall be filled on the basis of open competition. In respect of social reservations viz., Scheduled Castes, Scheduled Tribes, Backward Classes, Economically Weaker Sections, the vertical reservation will be applicable and the number of appointments reserved for that category shall in no way be affected during the period the reservation for that category is in force.

15.5. In the event of Schedule Caste & Schedule Tribe candidates not coming up for selection with the existing minimum prescribed for selection in the competitive examination conducted by the APPSC their selection shall be considered on the basis of rank with reference to their performance in the written competitive examination irrespective of the marks secured, as per G.O.Ms.No.631, G.A. (Ser.A) Dept., dt.05.09.1977.

15.6. Where the candidates get equal number of marks in the **Written Examination** if two or more candidates get equal total number of marks, those candidates shall be bracketed. Candidates within the same bracket shall then be ranked 1, 2, 3 etc., according to age i.e., oldest being considered for admission. In case there is tie in age, the person who possesses educational qualification at earlier date would be considered.

15.7. **Post, Division and District preferences will be taken at the time of certificate verification stage only.**

15.8. It is hereby clarified that the said preferences are only indicative for being considered to the extent possible but not binding or limiting the Commission's powers under Article 315 to 320 of the Constitution of India. Therefore, the Commission has the power to assign a candidate to any of the notified posts for which he/she is considered to be qualified and eligible, subject to fulfilling the selection criterion. Mere claim of preference for any Division/District for allotment against vacancy does not confer a right to selection for that Division/District in particular or any Division/District in general.

15.9. **DigiLocker:** APPSC is introducing a streamlined certificate verification process through DigiLocker, a Government of India digital platform; it allows securely storing and accessing digital documents issued by various Government Departments, including education certificates, identity proofs, caste certificates and more. Hence, all the applicants who are participating in recruitment process are advised to create a DigiLocker Account and fetch your certificates for giving consent to the APPSC to verify their certificates electronically at the time verification of certificates.

15.10. The appointment of selected candidates will be subject to their being found medically fit in the appropriate medical classification, and if he/she is of sound health, active habits and free from any bodily defect or infirmity.

15.11. **Memorandum of Marks:** After publication of final selection list, the marks list (total marks) of the successful candidates will be displayed on the Commission's website. However, Memorandum of their own Marks can be obtained individually after one month from the date of declaration of selection list in APPSC website on payment of Rs.200/- (Rupees Two hundred only) through IPO/DD in favour of Secretary, A.P. Public Service Commission, Vijayawada, for a period of Three Months only. Rejected, Invalid, Disqualified, ineligible candidates will not be issued any Memorandum of Marks and fees paid by such candidates, if any, will be forfeited to Government account, without any correspondence in this regard. Requests for Memorandum of Marks will not be entertained until the recruitment process is finalized.

**PARA-16: DEBARMENT:**

- 16.1. Candidates should make sure of their eligibility to the post applied for and that the declaration made by them in the format of application regarding their eligibility is correct in all respects. Any candidate **furnishing in-correct information or making false declaration regarding his/her eligibility at any stage or suppressing any information** is liable TO BE DEBARRED UPTO FIVE YEARS FROM APPEARING FOR ANY OF THE EXAMINATIONS CONDUCTED BY THE COMMISSION, and summary rejection of their candidature for this recruitment.
- 16.2. The Penal Provisions of Act 25/97 published in the A.P. Gazette No. 35, Part-IV.B Extraordinary dated: 21/08/1997 shall be invoked **if malpractice and unfair means are noticed at any stage** of the recruitment. Further candidates shall be liable for penalty as per G.O.Ms.No.385, G.A. (Ser. A) Dept., Dt.18/10/2016. The Chief Superintendent of the examination centre is authorized to take decision in case of malpractice or usage of unfair means or creation of disturbance or use of physical force by any candidate and report the matter to the competent authority as well as register a police case.
- 16.3. The Commission is vested with the Constitutional duty of conducting recruitment and selection as per rules duly maintaining utmost secrecy and confidentiality in this process and any attempt by anyone causing or likely to cause breach of this constitutional duty in such manner or by such action as to violate or likely to violate the fair practices followed and ensured by the Commission will be sufficient cause for rendering such questionable means as ground for debarment and penal consequences as per law and rules as per decision of the Commission.
- 16.4. Any candidate found **impersonating or procuring impersonation by any person** or resorting to any other irregular or improper means in connection with his / her candidature for selection or obtaining support of candidature by any means, such a candidate may in addition to rendering himself/ herself liable to criminal prosecution, be liable to be debarred permanently from any exam or selection held by the Service Commissions in the Country.
- 16.5. **ELECTRONIC GADGETS BANNED:**  
 (a) The use of any mobile (even in switched off mode), calculator or any electronic equipment or programmable device or storage media like pen drive, smart watches etc., or camera or blue tooth devices or any other equipment or related accessories either in working or switched off mode capable of being used as a communication device during the examination is strictly prohibited. Any infringement of these instructions shall entail disciplinary action including ban from future examinations.  
 (b) Candidates are advised, in their own interest, **not to bring** any of the banned items including mobile phones to the venue of the examination, as arrangement for safe – keeping cannot be assured.

**PARA-17: COMMISSION'S DECISION TO BE FINAL:**

The decision of the Commission in all aspects and all respects pertaining to the application and its acceptance or rejection as the case may be, conduct of examination and at all consequent stages culminating in the selection or otherwise of any candidate shall be final in all respects and binding on all concerned, under the powers vested with it under Article 315 to 320 of the Constitution of India. Commission also reserves its right to alter and modify the terms and conditions including vacancies laid down in the notification for conducting the various stages up to selection or withdraw the notification at any time duly intimating details thereof to all concerned, as warranted by any unforeseen circumstances arising during the course of this process, or as deemed necessary by the Commission at any stage.
