GENERAL GUIDELINES FOR RECRUITMENT

1. AGE:

- i. OC candidate should not have completed 42 years as on date of Notification.
- ii. EWS/SC/ST/BC candidates should not have completed 47 years as on date of Notification.
- iii. Differently Abled persons should not have completed 52 years as on date of Notification.
- iv. Ex-servicemen should not have completed 50 years as on date of Notification

2. FEE:

- i. Application fee for O.Cs - Rs.500
- ii. For SC, ST, BC, EWS, differently abled and Ex-servicemen - RS.350
- iii. Method of Payment: online transaction to The Principal Andhra Medical College on or before 31/07/2025 to the Bank account Number 103010011013226 with IFSC Code UBIN0810304 Growth Fund, **Andhra Medical College**, Visakhapatnam by UPI or by QR code shown Below:

3. Caste & Community:

- i. Community Certificate issued by the competent authority in terms of G.O.Ms.No.58 SW(J) Dept. dt:12-05-1997 (Candidates belonging to BCs, SCs & STs of other States are not entitled for reservations).
- ii. Rule of Reservation will apply as per G.O.Ms.No.77, GAD (Services D) Dept. dated.02.08.2023
- iii. Rule of Reservation for SC Sub Categorization will apply as per G.O.Ms.No.7, Social Welfare (CV) Dept.dated.18.04.2025

4. LOCAL CANDIDATURE:

- i. Cadre wise local status reservation in accordance with the G.O. Ms. No. 674 Dated: 20th October, 1975 GENERAL ADMINISTRATION (SPF) DEPARTMENT Presidential order on Organization of local cadres on regulation of Direct recruitment.
- ii. Candidates who are Local to Andhra Pradesh ONLY need to apply. (Candidates who studied from 4th Class to 10th Class in the State of A.P and candidates who migrated to any part of AP from the State of Telangana within a period of 3 years from 2nd June 2014. (As per G.O.No.132 GAD Dt.13-6-2016 & G.O.Ms.No.133 GAD Dt.13.06.2016) are considered as Local).
- iii. The Residence Certificate / Nativity / Domicile Certificate issued by MRO/Tahsildar will not be allowed for Local consideration without mentioning the GO.No.132 GAD Dt.13-6-2016 & GO.Ms.No.133 GAD Dt.13.06.2016 for the candidate who studied in the state of Telangana before bifurcation.
- iv. The Residence Certificate will not be accepted if a Candidate has studied in any Educational Institutions up to SSC or equivalent Examination; such candidates have to produce study certificates invariably.

5. SELECTION PROCEDURE:

- i. Selection will be based on merit and rule of reservation
- ii. Merit list will be prepared for all the candidates who applied and fulfilled all the eligibility conditions.
- iii. Selection lists will be prepared based on merit lists and Rule of Reservation issued in Total Marks–100.
- iv. 75% will be allocated for aggregate of marks obtained in all the years in qualifying examination or any other equivalent qualification.
- v. Maximum 10 marks based on weightage for number of years since passing qualifying examination @ 1 mark per year on completion to the date of issue of notification.
- vi. 15 Marks to the contract service rendered in Government institutions in the relevant post only.
- vii. Contract service can be calculated from the date of completion of Post-Graduation (Requisite qualification) only.
 - A. 2.5 marks per six months in Tribal Area.
 - B. 2 marks per six months in Rural Area.
 - C. 1 mark per six months in Urban Area.
- viii. Contract Service Certificate issued by the competent authority and signed by the Superintendent of Government Teaching Hospital / DM&HO / DCHS shall be submitted for claiming the contract weightage. Contract weightage will not be awarded, in case of non- submission of signed certificate from the above authorities (Annexure – III).
- ix. Service Weightage shall consider only when experience certificate produced by the individual is in the appropriate cadre only. Experience in any field other than to post applied shall summarily be rejected.
- x. Weightage will be awarded up to 15 Marks for the candidates who rendered their services on contract basis for COVID-19 duties.
 - a. Contract service will be reckoned up to the date of notification as per Government Memo.no.4274/D1/2013, HM&FW (D1) Dept., dt.10.07.2014.
 - b. Spells of services will also be considered for weightage marks.
 - c. Contract weightage will be awarded as per G.O.Rt.No.211, HM &FW(B2) Dept., Dated 08.05.2021 and G.O.Rt.No.7 HM&FW(B2) Department Dt.06.01.2022 read with circularno.03/CHFW/2022, dated 11.02.2022 of CHFW
 - d. Following documents to be submitted to claim COVID-19 weightage:
 - i. Appointment order for COVID-19 management.
 - ii. Monthly attendance certificates.
 - iii. Bank statement indicating payment of monthly remuneration along with COVID-19 weightage service certificate.
 - iv. Service certificate from the competent authority in the prescribed proforma (DMHO/DCHS/Medical Superintendent in case of GGH).
 - v. Covid-19 contract weightage will not be awarded in case of non- submission of any of the above certificates from e (1) to e(4)
 - e. @ 5 Marks per Six months of service for COVID 19 duties. (0.83 mark per each competed month)

Even though 15 Marks to contract and 15 Marks to Covid-19 services is allocated total marks is restricted to 15 only (not 30 marks) for both put together. One can claim 15 marks exclusively either from Contract or from Covid-19 services when put both together it should not exceed 15 Marks.

Note: The Contract/Covid-19 Weightage marks will not be applicable if they are already used to obtain same cadre of post in Govt Sector. The Contract/Covid-19 Weightage marks will be applicable only for other posts for which they are not used the weightage marks under Govt Sector.

6. HOW TO APPLY:

- i. Applications shall be submitted in the prescribed format shown in ANNEXURE-1 before 03/08/2025 in the Admin Building of Andhra Medical College from 26.07.2025 to 03.08.2025 up to 05.30 PM.
- ii. The candidates shall have to pay the application fee Rs.500/- for OCs and Rs.350/- for BC, SC, EWS, ST, Ex-service men and differently abled candidates.
- iii. Payment to the College on or before 03/08/2025 to the Bank account Number 103010011013226 with IFSC Code UBIN0810304 Growth Fund, **Andhra Medical College**, Visakhapatnam by UPI or through the QR code the application will be considered only if the payment receipt is submitted.

7. CERTIFICATES TO BE SUBMITTED WITH THE APPLICATION:

- i. Certificates and Marks Memos of all years for the respective post qualification
- ii. Technical Qualification certificate issued by competent authority.
- iii. Certificate of permanent Registration in A.P State Medical /Para Medical Council for the technician post wherever necessary.
- iv. SSC or equivalent certificate (for Date of Birth)
- v. Study Certificates from class 4th to 10th from the school where the candidate studied. If SSC or its equivalent done by private study, without attending any school, Residence certificate from MRO for previous 7 years (in the prescribed Proforma). In the absence of the above certificate the candidate will be considered as Non-Local.
- vi. Copy of the latest Caste Certificate in case of SC/ST/BC/EWS (with categorization if any) issued by MRO concerned. In the absence of proper certificates, the candidate will be considered as OC only.
- vii. Contract Service certificate should be submitted in the prescribed format attached in the web site obtained from the controlling officer concerned (DM&HO/ DCHS / Superintendent of teaching hospitals / Any other authority who appointed the applicant). In absence of which the candidate will not be given any weightage.
- viii. For availing COVID weightage – COVID appointment orders should be attached to the application along with contract service certificate, if not submitted COVID weightage will not be considered.

The applications submitted without the required certificates and incomplete applications will be rejected.

8. THE CERTIFICATES TO BE ENCLOSED WITH THE FILLED APPLICATION:

- i. SSC or its equivalent (for date of birth).
- ii. Pass certificates of qualifications prescribed for the posts concerned.
- iii. Proof of appearance for the qualifying examination where ever applicable.
- iv. Marks memos of all years of qualifying examination or its equivalent. In the absence of marks memos, marks will be calculated as per rules in force.
- v. Valid certificate of registration in A.P. Para Medical Board/ Allied Health Care sciences / any other council constituted under the relevant rules for specific courses where ever applicable.
- vi. Study Certificates from class IV to X from the school where the candidate studied. In case of private study local candidature certificate for that particular 7 years period preceding the year of passing X class from competent authority in Form Appendix I certificate of residence prescribed vide Sub clause (ii) of clause (a) of para 7 of the Presidential Order (proforma is herewith enclosed).
Candidates migrated from Telangana State shall submit their certificate of Local candidature as per GO No 132 & 133 dt: 13.06.2017. In the absence of the suitable certificate, the candidate will be considered as non-local and further action will be as per rules in force.
- vii. Copy of valid caste certificate (Latest). In case of non-submission of valid caste certificate, the candidate will be considered as OC.
- viii. Latest EWS (Economically weaker sections) certificate issued by the competent authority in case of the EWS categories.
- ix. Certificate of disability issued in SADAREM.
- x. Service certificate from the controlling officer concerned (DM&HO/DCHS/ Principals of GMCs / Superintendent of GGH / Any competent authority who appointed the applicant) for claiming weight age for Contract/outsourcing/honorary service, in the absence of which the candidate will not be given service weightage (proforma is herewith enclosed).

9. ANY OTHER CERTIFICATES AS RELEVANT AND APPLICABLE.

Note: Candidates must submit clear, visible documents failing which application will be summarily rejected. Applications without the above documents will be summarily rejected.

10. IMPORTANT INFORMATION TO CANDIDATES:

- a. If selected, he/she should stay at the bonafied Head Quarters compulsorily.
- b. If selected and appointed he / she should abide by the Government rules in force regularly from time to time.
- c. Candidates are advised to follow official website of the district from time to time for further information.
- d. Selected Candidates will be intimated about Counselling through their Registered Mobile Number and Email ID 's Submitted in their applications and through NIC Visakhapatnam official website.

11. TENURE OF APPOINTMENT AND IMPORTANT CONDITIONS:

The tenure for the contract/outsourcing posts is initially one year from the date of joining in the post and may be extended for further period as per the instructions issued by the Government from time to time. The District Selection Committee reserves all the rights to terminate the contract / outsourcing services of any candidate / candidates at any time with one month notice or as per directions of the Government from time to time.

12. DEBARMENT:

- a. Candidates should make sure of their eligibility to the post applied for and that the declaration made by them in the format of application regarding their eligibility in all aspects. Any candidate furnishing in-correct information or making false declaration regarding his/her eligibility at any stage or suppressing any information is liable to be debarred from recruitment conducted by the department and summarily rejection of their candidature for this recruitment & future recruitment.
- b. The department is vested with duty of conducting recruitment and selection as per rules duly maintaining utmost secrecy and confidentiality in this process and any attempt by any one causing or likely to cause breach of this duty in such manner or such action as to violate or likely to violate the fair practices followed and ensured by the department will be sufficient for rendering such questionable means ground for debarment.

13. **DEPARTMENT'S DECISION TO BE FINAL**

a. The decision of the department regarding acceptance or rejection of the candidature, conduct of counselling and at all consequent stages culminating in the selection or otherwise of any candidates shall be final in all respects and binding on all concerned under the powers vested with. The department also reserves its right and modify regarding time and conditions laid down in the notification for conducting the various stages up to selection duly intimating details thereof to all concerned as warranted by any unforeseen circumstances arising during the course of this process.

b. All interested and eligible candidates shall apply after satisfying themselves that they are eligible as per the terms and conditions of this recruitment notification.
