**Selection Criteria – Candidates will be selected based on the following criteria:**

Marks obtained in MD/MS/DNB PG Degree for Assistant Professor and Senior Resident posts. Marks obtained in MBBS for Tutor posts. (If marks are not awarded in the qualifying exam 50% of marks will be considered)
For Professor and Associate Professor the duration of their teaching experience in that Cadre will be considered for Selection Criteria.
Rule of Reservation will be followed wherever applicable.
Marks obtained in MBBS Degree for Tutors post.
For local candidature – Bonafide/Study conduct certificates from class 1 to class 7 shall be considered.

- 1. DNB Candidates will be selected as per the latest existing NMC guidelines.**
- 2. Selection of candidates will be *Nationwide (first preference is given to the local candidates, if local candidates are not available candidates from other states will be considered)***
- 3. *The age of the applicant should be below 69 years as on Date of issue of this notification.***

- 4. The selected candidate will have to submit the relieving order from their previous institute, failing on which their selection will stand cancelled.**

5. *The candidates who have joined and working in any other Government Medical Colleges of Telangana on Contract basis in same cadre are not eligible to Apply*
6. During the period of contract, the faculty will be paid a consolidated monthly remuneration depending upon the post as per G.O. Rt. No. 98 from Finance (HRM.VII) Department, Govt. of Telangana dated 11.03.2024. The remuneration shall be all inclusive and subject to deduction of tax at source and/ or any other statutory deductions to the extent required under the laws.

**Terms and Conditions:**

1. The appointment as contract employee is purely on temporary basis for a period till 31.03.2026 or till the vacancies are filled by promotion / regular appointment, whichever is earlier. ***This contract placement does not confer any right for future Government appointment.***
2. The selected candidate should submit the original certificates, Medical Fitness Certificate issued by Civil Surgeon at the time of joining along with one year bond on Rs. 100 stamp paper duly notarized to the concerned Principal of the Medical College. Candidate must give 3 months notice period if he / she wants to leave, If any candidate breaks the bond, he/she has to pay 3 months' salary.
3. The contract is liable to be terminated at any time with a one-month notice during tenure period, if any misconduct is noticed.
4. The engaged faculty will be at the disposal of the institute on whole time basis and his/her service may be utilized in any manner required by the Competent Authority of the Institute without any claims for any additional remuneration.
5. The original documents should be brought for verification at the time of walk in Interview.
6. The Selected candidates should join duties with in (ONE) week.
