Applications are invited from Indian Nationals possessing prescribed eligibility criteria and having qualified in Graduate Aptitude Test in Engineering (GATE) Exam with valid GATE Score Card for direct recruitment in the grade of Deputy Field Officer (Technical) [Level-7 in Pay Matrix, Group 'B', Non- Gazetted] in Cabinet Secretariat, Government of India.
