



Notification No. 10/2022-Estt dated 21.10.2022

The High Court of Andhra Pradesh issued Notification No. 10/2022 on 21.10.2022 inviting applications from the candidates and conducted computer based objective type examination on 20-01-2023 for filling-up 16 posts of Typists and 20 posts of Copyists.

The Registry has placed the list of 128 qualified candidates on the official website of the High Court on 23.02.2023 directing the candidates to appear verification of original certificates and skill test in typing on 06.03.2023 in the High Court premises.
