#### ORDER:

In the reference 1<sup>st</sup> read above, Government have formulated Job Chart of Village Surveyors - Grade – I, II & III by fixing (20) functions to them and ordered that the said functions shall be followed by Village Surveyors strictly.

- 2. In reference 2<sup>nd</sup> read above, the Commissioner, Survey Settlements and Land Records, Andhra Pradesh, Vijayawada has submitted proposals stating that to rationalize the Job-Chart of Village Surveyors in the interest of efficient service delivery and requested to issue orders accordingly.
- 3. Government after careful examination of the proposed new Job-Chart, and hereby accepted and fixed the following functions to the Village Surveyors- Grade-I, II & III:
- I. **DEMARCATIONS (F-lines):** Pointing out F-lines on application from parties and Government bodies including approved layouts.

### II. SUB-DIVISION WORK AND INCORPORATION OF CHANGES:

- a. Survey of Gramakantam, detailed street survey / Town Survey.
- b. Measurement work of new Subdivisions or clubbing of old subdivisions applied by citizens, and as entrusted by the Commissioner, SS&LRs, Andhra Pradesh from time to time and incorporation of the same in both village accounts after getting them scrutinized by the competent authority.

#### III. GRIEVANCE PETITIONS:

To attend all Grievance petitions applied at GSWS, referred by department authorities and submit timely reports.

## IV. RENEWAL OF MISSING SURVEY MARKS:

- a. Issue of draft notices under Section 15(2) of the Survey and Boundaries Act to the concerned for renewal of missing / damaged / removed survey points / Survey marks / Ground Control points in the villages in his jurisdiction.
- b. Renewal of missing stones detected for which section 15(2) notices have been served after completion of stipulated period.

## V. INSPECTIONS:

Inspection of 10% maintainable survey points / Survey marks / Ground Control points in the Villages in his jurisdiction every month.

## VI. CORRECTION OF RECORDS:

Measurement and plotting of subdivisions in the village copy of FMB/LPM/PPM and correction of related Village Accounts, under the orders of the Competent Authority.

## **VII. GENERAL INSTRUCTIONS:**

- a. Should attend the inspections of all the Higher officers as and when informed.
- b. Servicing and Maintenance of Survey instruments and Equipment allotted to Village Surveyors.
- c. Submission of monthly tour dairies, monthly progress statements and any information as may be prescribed by Commissioner, SS&LRs, Andhra Pradesh.
- d. Conduct survey operations using modern / survey instruments like ETS, DGPS / CORS or any other equipment or technology adopted the Department from time to time.
- e. Assist Village Revenue officer(VRO) as and when called to do so.
