Sub: Animal Husbandry Department –Conducting Jagannana Pasu Arogya - Suraksha camps – Organizing Pilot camps at North Coastal, Central Coastal and Rayalaseema districts during the month of November 2023– Certain instructions/guidelines – Issued – Regarding.

Ref:-Organizing Jagananna Pasu Arogya Suraksha Camps (JPASC) in the State.

The attention of the DAHOs, I/c District Administration in the State is invited to the subject & reference cited, wherein it is proposed to conduct Jagannana Pasu Arogya Suraksha camps (JPASC) similar to Jagannana Aarogya Suraksha Camps being organized by the State Government.

The Jagannana Pasu Arogya Suraksha camps (JPASC) are scheduled from 1<sup>st</sup> December to 31<sup>st</sup> December 2023. The camps are to be organized @ 4 camps per mandal (1 mega and 3 medium camps). The detailed SOP for conducting JPASC will be communicated.

Before the commencement of JPASC, it is proposed to organize One Pilot camps covering 3 regions. In North Coastal Vizainagaram district, Central Coastal NTR district and in Rayalaseema-Tirupati district during the month of November 2023 to assess logistical requirements viz animal turnout, specialist doctors, medicines etc.

The schedule for the organization of pilot camps:

The pilot camps should be organized as per the SOP designed for conducting Jagannana Pasu Arogya Suraksha camps (JPASC)

The DAHOs of Vizainagaram, NTR and Tirupati districts are requested to follow the guidelines for successful organization of pilot camps as mentioned below:

I. <u>Preparatory arrangement for the Camps:</u>

- An action plan shall be prepared well in advance in consultation with Public representatives.
- All the farmers shall be informed well in advance.
- Wide publicity shall be given through print and electronic media.
- The camp shall be conducted at a suitable place where a large number of animals can be accommodated.
- All necessary drugs and medicines for the camp shall be positioned.
- The DAHO's shall ensure a minimum of 500 animals to attend the pilot camp.

## II. Formation of Veterinary Teams:

- Veterinary Teams shall be formed with the following.
- Assistant Director AVH
- Local Veterinary Assistant Surgeon
- Specialist Doctors from Department/SVVU (Gynecology, Medicine, Surgery)
- Internee students from SVVUniversity.
- Screening team from ADDLs /CADDLs.

# III. General Arrangements for the camp:

• The following minimum requirements shall be ensured at pilot camps.

### IV.On the Day of Camp:

- Local Public representatives must be informed priorly and ensure their participation.
- Hon'ble Ministers and Hon'ble Public Representatives shall be invited to inaugurate the camps where ever possible.
- · Rythu Sadassu's will be organized along with camps for awareness on

flagship programmes of the Government and scientific management of livestock.

• The camp should have the following Counters & Wards.

Registration counter

Gynaecology ward

Surgical ward

Medical ward

Calf ward

Diagnostic counter

Drug distribution counter.

- After registration, based on the history, the animal will be allotted to the respective wards.
- Necessary examinations will be done by the specialists at the respective wards and administer medicines as per the recommendations will be taken up.
- The prescribed drugs will be issued to the farmers on Free of Cost from Drug distribution counter.
- Nutritional supplements will be distributed to the pregnant and lactating animals.
- Preventive seasonal vaccinations will be taken up with special focus on Brucellosis.
- Deworming against parasitic infestation based on examination will be taken up.
- All diagnostic tests will be carried out with Staff of YSR Constituency level disease diagnostic labs.
- Spot disease diagnosis will be done for all except culture tests and Antibiotic Sensitivity Tests which will be treated at the time of follow up.
- All reproductive disorders, health interventions and surgical interventions will be carried out.
- Animals requiring major surgical interventions will be given date of surgery in the nearby veterinary polyclinic and on that date they will be transported through Dr. YSR Pasu Arogya Seva Ambulances (1962).
- Artificial Insemination & Sex sorted semen insemination will be

conducted.

## V. Treatment of Follow-up cases:

- Follow-up of treated animals till recovery by the concerned Veterinary Assistant Surgeon.
- Sufficient medicines shall be positioned for the treatment of follow-up cases.
- Records maintenance with proper acquittance of farmers to whom the medicines are supplied during the health camps and thereafter for follow-up.

#### VI. Monitoring of camps:

- DAHOs and Divisional Deputy Directors shall monitor the camps.
- The details of camps organized, number of animals treated and number of farmers benefitted shall be reported to the Head Office promptly.

The Director along with senior officers from the Head office will be attending the camps.

The DAHOs shall incur the expenditure towards organizing the camps from the available interest funds.

Hence, DAHOs of Vizainagaram, NTR and Tirupati districts are requested to make all necessary arrangements for conducting pilot camps as per the schedule.
