The Government is committed to the Welfare and development of all segments of the Society. Enhancement of pension amount is a major welfare measure to ameliorate the hardships of the poor and vulnerable sections of the society, particularly the old and infirm, widows, and persons with disability etc., to secure a dignified life.

- 2. The attention of the Chief Executive Officer, SERP & all the District Collectors, Project Directors of DRDA, MPDOs & Municipal Commissioners in the State is invited to the references cited.
- 3. Vide reference 6th cited, the Government issued orders for the following:
 - a) Enhancement of existing pension amount from Rs. 3,000/-month to Rs.4,000/- month for OAP, Widow, Weavers, Toddy Toppers, Fishermen, Single Women, Traditional Cobblers, Transgender, ART(PLHIV), Dappu Artists and pensions to Artists.
 - b) Enhancement of disabled persons pension from Rs. 3,000/- to Rs.6,000/- to all persons with disability and multi deformity Leprosy persons.
 - c) Enhancement of pension to fully disabled persons from Rs. 5,000/- to Rs.15,000/-.
 - d) Enhancement of pension amount from Rs. 5,000/- to Rs. 10,000/- for persons with Chronic diseases viz., Bilateral Elephantiasis-Grade 4, Kidney, liver and heart transplant, CKDU not on Dialysis CKD Serum Creatinine of >5 mg, CKDU Not on

Dialysis CKD estimated GFR <15 ml, CKDU Not on Dialysis CKD Small contracted kidney.

- e) The enhanced pensions mentioned at (a) shall be payable from $1^{\rm st}$ April, 2024 disbursed from $1^{\rm st}$ July, 2024 along with 3 months arrears. Thus, the amount to be disbursed under this category will be Rs.7000 in the month of July, 2024. Thereafter Rs.4000/-month shall be disbursed every month.
- f) In respect of (b), (c) & (d) mentioned above, the enhanced pension amount shall be disbursed from 1st July, 2024.
- 4. The enhancement in different categories of pensions is represented in a tabular form as shown below:

- 5. In supersession of the reference 2nd, 3^{rd,} 4th & 5th cited, the following instructions are issued on disbursement of Social security Pensions in the State, from the month of June 2024, payable in the month of July,2024.
 - i. (a) All categories of Pensions as mentioned in the table at para 4 shall be paid at the enhanced rate as shown in the table.
 - (b) Eleven (11) categories of pensions mentioned at sub category I (serial number 1 to 11) in the table shall be paid along with the arrears for the months of April, May and June 2024. Therefore, the pensioners in this category shall be disbursed at the rate of Rs. 7000/ (arrears- Rs. 3000/ plus enhanced Rs.4000/) in the month of July 2024. Thereafter they shall continue to receive their pensions at the rate of Rs. 4000/ per month from the month of August 2024.
 - (c) Appropriate provision as per para i (a) and (b) shall be made in the Pensions Software and Apps.
 - ii Pension disbursement shall be by way of cash at the doorstep of the pensioners.
 - iii. The pension amount will be disbursed by Village / Ward Secretariats functionaries.
 - iv. It shall be ensured that on an average each village/ward secretariat functionary is assigned not more than 50 beneficiaries for distribution of pensions. The District collectors shall utilize the services of other government functionaries, wherever the required number of village/ward secretariat functionaries are not available for distribution of pensions duly

ensuring that not more than 50 pensions are assigned to any village/ward secretariat functionaries/other government functionaries.

- v. The details of such deployed additional other government functionaries shall be updated in the MPDO & Municipal Commissioner logins to enable access to the mobile application.
- vi. Funds required for the pension disbursement shall be made available at the concerned bank branches on the last bank working day of the month. Panchayat Secretary/Ward Administrative Secretary, Welfare & Education Assistant/Ward Welfare Development Secretary will withdraw cash and hand over to all the pension disbursement functionaries well in advance, so that the pension disbursement will taken up on 1st day of the month.
- vii. Pension disbursement shall start at 6.00 AM in the morning and shall continue till most of the pensioners are disbursed their pensions on the $1^{\rm st}$ day of the month itself. District Collector shall ensure that any leftover pensions are compulsorily covered on the following day i.e. $2^{\rm nd}$ day of the month.
- viii. All the pension disbursements are to be made through Aadhaar Biometric/facial / IRIS / RBIS authentication.
- ix. Regarding ART (PL HIV) & Disabled students studying outside AP, the pensions will be disbursed in DBT mode.
- 6. The CEO, SERP, MDs of welfare corporations, Commissioner, APCRDA, and all District Collectors are requested to take necessary action accordingly and follow the instructions of the Government issued.
- 7. The Project Director, DRDAs shall communicate these instructions to all the MPDOs/ Municipal Commissioners and disburse the pensions smoothly.
