The Government have decided to implement the Direct Benefit Transfer (DBT) system for delivering social benefits to eligible beneficiaries. In this regard, the Department has verified the National Payments Corporation of India (NPCI) status for all household members above the age of 18. The NPCI status report can be accessed on the Navasakam Beneficiary Management (NBM) Portal. Accounts of NPCI-inactive members must be activated before 15th November 2024.

In this regard, it is to inform you that a total of **64,81,632** NPCI-linked bank accounts of citizens have been identified as inactive. District-wise details are as follows:

The GSWS department has already deployed a module in NBM for monitoring progress of NPCI linkage with the bank accounts of the citizens. All the District Collectors are requested to issue the following instructions to all Village/Ward Secretariat Functionaries to expedite the progress of NPCI linkage with the bank accounts of the citizens:

- 1. The Beneficiary wise details of NPCI inactive list shall be downloaded from Digital Assistant / Ward education and data Processing secretaries and Welfare & Education Assistant / Ward Welfare and development secretaries.
- 2. Village / Ward Secretariat staff shall visit the beneficiary and inform the following action points to the beneficiaries to make the NPCI status active.
- a. Opening of Savings account in any Nationalized Bank/ Postal bank and link with NPCI consent.
- b. If savings account is available, Mapping it with Aadhaar with NPCI consent at respective bank.
- c. Coordinate with nearest bank/post office for opening of new accounts or

- mapping of Aadhaar with NPCI consent.
- 3. Welfare & Education Assistant / Ward Welfare and development secretaries shall update the activation status in the NPCI action taken module of NBM portal.
- 4. The following options will be available to mark the status for NPCI Inactive beneficiaries.
- a. New account opened and Mapped with Aadhaar with NPCI consent.
- b. Existing account Mapped with Aadhaar with NPCI consent.
- c. Beneficiary Died.
- 5. Lead District Manager shall be requested to coordinate with Banks and Post payments Bank to conduct special account opening / NPCI link camps at the Village / Ward secretariats in coordination with local secretariat staff.

As the Government is closely monitoring this task, you are requested to involve all secretariat staff and ensure to complete the activity on or before  $15^{th}$  November, 2024.
