2. As part of the Zero Poverty Initiative under the Swarna Andhra Mission, the government is in the process of identifying the bottom 20% of households across the state. This is being accomplished through a survey across 10 districts in collaboration with the GSWS department which is scheduled to take place from 20th February, 2025, to 2nd March, 2025 in the first phase.

3. In this regard, comprehensive training on the P4 survey has also been provided to the identified Master Trainers by the Planning and GSWS departments on 18.02.2025. In turn, the Master Trainers will train the Village/Ward surveyors.

4. To ensure smooth completion of the survey within the stipulated time, regular monitoring and supervision is essential at various levels. The following arrangements shall be carried out by the District Collectors at different levels.


A. Village/ Ward Secretariat employees shall serve as surveyors for P4 Survey within their jurisdiction/cluster area. Proper deployment of surveyors is to be ensured

B. MPDos/ Municipal Commissioners shall be responsible for ensuring smooth and timely completion of the survey and overall co-ordination in their respective Mandals/ Municipalities.

C. Chief Planning Officer shall serve as the overall coordinator of the survey at the district level.

D. The District Collector shall conduct the review meetings with the
aforementioned Nodal Officers and enumerators of the survey periodically
in co-ordination with the GSWS department at district level.

Therefore, the Collectors in the address entry are requested to ensure the above
arrangements and to issue instructions to the concerned field staff for the smooth
and timely completion of the survey.
