#### ORDER:

Whereas, in the reference 3rd read above, the Director of Agriculture, Andhra Pradesh, Guntur has requested the Government to issue a revised order to implement the modified process flow for distribution of subsidy seed through the D- Krishi application, as detailed below. It is also stated that in the G.O's read above, the Government has issued Standard Operating Procedure (SOP) for distribution of subsidy seed at village level through Rythu Bharosa Kendralu (RBKs) from the year 2021-22.

- 2. After careful examination of the proposal, the Government hereby accords approval for implementation of the modified process flow for distribution of subsidy seed through D-Krishi application as proposed by the Director of Agriculture, A.P., Guntur. The detailed modified process flow is as follows:
  - a) Allocation will be made by the State District Mandal RSK. The AP Seeds will supply quantities directly to RSKs (total / part of allocation) through a truck and RSK wise stock entry will be made along with truck details.
  - b) The Rythu Seva Kendralu in-charge shall identify the beneficiary farmers in the Village for subsidy seed of each crop specifically as per the guidelines and subsidy pattern issued by the Commissioner & Director of Agriculture.
  - c) The Rythu Seva Kendralu in-charge shall identify the beneficiary farmer duly authenticating through D Krishi App. Farmer identification will be made through Aadhaar Biometry / Face recognition / OTP to Aadhaar seeded mobile.

- d) Aadhaar seeded mobile can only be used for authentication of the farmer (as it was done in case of e Crop) & customized message need to be sent from NIC as per the choice of the farmer (as already identified). After Authentication, the Farmer shall be issued with (SMS) customized message (OTP, OTP id, Crop, Variety, Bags allotted, Acres, Subsidy amount in Rs, Non subsidy amount payable in Rs, Village, Mandal.)
- e) By using these OTP & OTP IDs (Acknowledgement number) the beneficiary farmer identified through D Krishi App, will make payment the Non-Subsidy Amount in GSWS payment gateway (through VAA login). The quantity of the stock for which the non-subsidy was paid through the GSWS payment gateway, shall be reflected in the reports as quantity distributed. The Rythu Seva Kendralu incharge shall issue a payment receipt to the Farmer. The Non-Subsidy amount collected by the Rythu Seva Kendralu incharge shall be deposited in the Andhra Pradesh State Seeds Development Corporation Limited (APSSDCL) Account on the same day.
- f) After that, Rythu Seva Kendralu incharge shall distribute the seed to the beneficiary farmer. The seed shall be distributed to the beneficiary farmers on the same day. The Rythu Seva Kendralu in-charge shall ensure that the entire indented quantity of seed is distributed on the same day to the farmers.
- g) If online payment is rolled on, which is under process of development, the system automatically leads to payment if farmer want to pay amount immediately without asking for any OTP IDs (Acknowledgement number).
- h) The District Agricultural officer shall submit the Utilization Certificate of the Subsidy Seed distributed to farmers to the Commissioner & Director of Agriculture within (15) days of the completion of the distribution of the Subsidy Seed of specific crop in the district for release of Subsidy amount to APSSDCL.
- 3. The Director of Agriculture, A.P., Guntur, the Vice Chairman & Managing Director, A.P. State Seeds Development Corporation Limited, Vijayawada, and the Vice Chairman & Managing Director, A.P. State Agro Industries Development Corporation Limited, Vijayawada, shall take further necessary action accordingly, in the matter.
