ORDER:-

Accordingly, Government hereby accord permission to the District Collectors of affected Districts for distribution of essential commodities, free of cost to the affected families who were put in relief camps and fishermen whose livelihood got affected. The items for distribution are as follows:-
 - 1. Rice 25 Kgs. (50 Kgs for weavers and Fishermen)
 - 2. Red Gram Dal -1 Kg.
 - 3. P.Oil -1 Ltr.
 - 4. Onions 1 Kg.
 - 5. Potatoes 1 Kg.
 - 6. Sugar 1 Kg
- 3. The above sanction is in addition to the eligible benefits under SDRF norms issued in the GO 2nd read above.
- 4. The Commissioner of Civil Supplies and Ex-Officio Secretary to Government / VC & MD, Andhra Pradesh State Civil Supplies Corporation Limited, Vijayawada is requested to take necessary action for distribution of Rice, Red Gram Dal, P.Oil and Sugar duly taking the required indents from the District Collectors concerned immediately and submit the necessary consolidated proposals to the Government for reimbursement of the amount immediately.
